Briefing Items

3. <u>18-0294</u> Local Employment and Apprenticeship Training Program Proposed Code Changes. [Clifford Armstrong, Local Employment and Apprenticeship Training Program Contract and Program Auditor, Community and Economic Development Department]

> At approximately 10:11 a.m., Clifford Armstrong, Contract and Program Auditor, Community and Economic Development, provided background information about the Local Employment and Apprenticeship Training Program (LEAP). Mr. Armstrong reviewed the minimal changes to the program since 1997, current challenges, proposed revisions, outreach proposals, stakeholders consulted, next steps, and recommendations.

Discussion ensued throughout regarding community power funds and economically distressed areas, the number of labor hours and multipliers, community empowerment zone goals, how the standard goals on contracts were initiated, who is standardized to meet these goals, how the Economic Development Committee Minutes March 27, 2018

apprenticeship involves City residents, how the goals are separated, and how revisions will impact the program. Discussion continued on letters to waive hardships, project timelines, contacts throughout the duration of the projects, non-profit or employment agencies involvement, contractor fines, the proposed new language in the Tacoma Municipal Code, how LEAP applies to any Tacoma Public Utilities service areas, performance outcomes, current internal and external disparities, and project thresholds. Discussion concluded on what is being done differently to help achieve goals, how the current program holds up accountability, regional public owners and collective actions, programming and outreach, consideration for a smaller LEAP percentage goal, concerns for apprentices to meet goals, contracting between now and summer months that will effect implementation, and consideration of a pilot program.

Public comment was heard from:

1. Tim Atteberg, Associated General Contractors of Washington.

MOTION: Mayor Woodards moved to recommend the proposed LEAP code changes for a one-year pilot to the full City Council.
