**5. Brief Program Description:** Northwest Integrated Health submitted a branch application to DBHR on February 15, 2018, for certification of an opiate substitution treatment program (OTP). The OTP is proposed to be located at 3727 South Tacoma Way, Tacoma, Washington 98409

Northwest Integrated Health presently has three DBHR certified behavioral health agencies in Pierce County at the following addresses:

Northwest Integrated Health has been providing DBHR certified behavioral health treatment services since July 24, 2013. Northwest Integrated Health has been providing DBHR certified OTP behavioral

health treatment services at their Northwest Integrated Health- Lakewood branch in good standing since August 1, 2016.

Northwest Integrated Health's current Pierce County OTPs is registered with the Washington State Board of Pharmacy, licensed by the federal Drug Enforcement Administration (DEA), are certified by the federal Center for Substance Abuse Treatment (CSAT), Substance Abuse and Mental Health Services Administration (SAMHSA), and are accredited by the federally recognized accreditation body of DBHR

Public hearings for the prospective OTP were previously held by DBHR in Pierce County in Tacoma on March 30, 2018; and in Tacoma on May 10, 2018, to allow the community where an OTP will be located to present testimony to DBHR on the proposed OTP as per RCW 71.24.590(1)(h).

#### 1. Please comment on support by city or county legislative authorities for proposed OTP services.

The Tacoma City Council is supportive of medically assisted opioid treatment, and acknowledges the need for greater availability of medically assisted opioid treatment. The Council supports well run medically assisted opioid treatment facilities which are good neighbors, and do not create adverse impacts on adjacent residents and businesses. The Council emphasizes the need for geographic dispersal of medically assisted opioid treatment facilities, so they are not concentrated within one, or a limited number of neighborhoods or business districts, and are sited at locations with ready access to public transit.

The Council encourages, and invites the Washington State Department of Social and Health Services, DBHR to engage early and collaboratively with local jurisdictions in assessing the need for additional medically assisted opioid treatment facilities, and identifying criteria for appropriate siting of those facilities to meet identified community needs without adversely impacting neighboring residents or businesses.

## 2. Please comment on the proposed site location.

The Northwest Integrated Health Lakewood facility is located at 9720 South Tacoma Way, and the proposed facility is to be located at 3727 South Tacoma Way essentially bracketing the South Tacoma Way Business District. The Council has concerns regarding this concentration of medically assisted opioid treatment facilities within a single region and business district. The site is zoned "CIX" Commercial Industrial Mixed Use. The proposed use of the site is permitted. Though the City of Tacoma code allows the proposed facility, it should be noted that a marijuana processing facility is located across the street.

#### 3. Please comment on the accessibility of transportation to the proposed site.

The nearest regular Pierce Transit service is Route 52 with current stops at South 35th and Union and at South 38th and Warner, which is a substantial uphill walk from the site. The Council has concerns regarding transit availability, particularly with regard to the uphill walk required of patients following daily treatment. Regarding vehicle access, the site fronts on South Tacoma Way, which is an Arterial street and includes off street parking.

# 4. 4. Comment on coordination of proposed OTP with other health care service providers within the service area.

Though members of the City Council attended both DBHR public hearings, the Council has no information regarding coordination between the proposed OTP with other health care service providers within the service area. This lack of information underscores the Council's concerns regarding a lack of early and collaborative engagement with local jurisdictions and communities.
