## STUDY SESSION/WORK SESSION

3. The City Council Study Session of Tuesday, June 19, 2018, will be held in Room 16 of the Tacoma Municipal Building North, at Noon. Discussion items will include: (1) Department of Ecology's Tacoma Smelter Plume Project Update; (2) Pierce Transit Bus Rapid Transit Project Update; (3) Other Items of Interest; (4) Committee Reports; (5) Agenda Review and City Manager's Weekly Report; (6) Closed Session – Labor Negotiations; and, (7) Executive Session – Review the City Manager's Performance.

At Tuesday's Study Session, the Washington State Department of Ecology staff will provide their **annual update on the Tacoma Smelter Plume Project**. The presentation will include a brief history of the project, work to address soil contamination, progress of soil sampling and replacement, and their work with developers to address contamination during development.

In addition at Tuesday's Study Session, Pierce Transit will present the preferred option for the Bus Rapid Transit (BRT) proposal and will be seeking the City Council's input before the Pierce Transit Board makes their final decision on July 9th.

## Public Art Program for the Eastside Community Center

The City of Tacoma's Office of Arts & Cultural Vitality in partnership with Metro Parks Tacoma is managing the public art program for the Eastside Community Center. Capacity building and training of Tacoma's local artists is a key strategy in Artful Tacoma and a shared value with Metro Parks.

As part of the new Eastside Community Center, 12 talented artists are participating in a training program to learn how to create art in the public realm. Each artist will install a temporary art installation June 16-22 at Salishan as part of that training. ### **Background:**

This correspondence provides a response to questions asked by City Council Member Hunter regarding capital improvements at the Pantages during the presentation about the design and construction agreements with Broadway Center for the Performing Arts at the Council meeting on May 8, 2018.

#### **Question Subject**

Council Member Hunter asked for additional information about the history, funding, and schedule of the planned Pantages Theater capital improvements.

### **Staff Response:**

The City of Tacoma (City) has contracted with the non-profit Broadway Center for the Performing Arts (BCPA) to operate the Pantages and Rialto Theaters, Theatre on the Square and the associated Jones Building since 1983. The management agreement was most recently renewed in 2016 and will expire in 2020.

In 2005, the City conducted a needs assessment for the theaters, which outlined considerable deferred capital maintenance and required upgrades totaling more than \$35 million. Between 2006 and 2016, critical improvements were made to preserve the historic buildings, increase safety, improve ADA access, and enhance patron comfort and improve efficiencies, at a total cost of approximately \$14 million. These improvements were funded by the City, with contributions of non-municipal funds acquired by BCPA, including State of Washington arts capital funding. BCPA managed these projects as part of its maintenance oversight role.

### Multi-Year Funding

On February 3, 2015, the City Council adopted Resolution No. 39108, pledging to fund \$10 million in theater improvement needs through 2020. Since 2015, the exterior of the Pantages and Jones Building have been fully restored, and concurrently design and engineering work for interior restoration and seismic upgrades were undertaken. The funding for these projects consisted of \$2.5 million from the City, supplemented with State of Washington funds secured by BCPA. The scope of work for 2018 has been narrowed to \$6.605 million, consisting of \$5.635 million of City funds supplemented by a \$970,000 grant procured by BCPA from the State of Washington Capital Budget. The City portion includes its pledged funding brought forward from 2019-2020. On May 8, 2018, the City Council adopted Resolution No. 40006 which approved the contract with Korsmo Construction for the 2018 phase.

### Funding Issues/Phasing

The new 2018 federal tax code has affected the availability of funding from "new market" tax credits. Tax credits, along with corporate sponsorships to be secured by BCPA, were to account for up to one-third of the overall project budget. Tax credits are estimated by BCPA to drop from a projected \$4.5 million to a possible \$750,000, which is not yet secured. Due to the lack of funds generated through the private sector and tax credits, what was initially planned as a single-phase capital project to be completed during an

18-month closure (to include full seismic upgrades) will now be completed in multiple phases as further funding becomes available. The impact of budget changes/lack of funding has been a moving target. Impacted parties including resident arts organizations were notified by the BCPA there might be a revised construction schedule beginning on February 8, 2018.

### 2018 Scope of Work

The 2018 phase entails complete restoration of the historic interiors of the Pantages Theater. Included in the scope of work are improved seismic security for the plaster and stained glass canopy, a new theater floor, new seats, historic restoration of paint and plaster, and improved acoustic systems including a new orchestra shell, new production equipment and the restoration of a center aisle. These investments will improve patron safety and comfort as well as enhance the ability to generate revenue. In order to facilitate this construction work, the Pantages is closing from May 14, 2018, to November 14, 2018. Full seismic support of the facility will occur in a later phase as funds become available.

To date, BCPA has secured \$1.9 million in pledges through its Centennial Campaign to support the costs of BCPA project management, fund raising, communications, and future phases of improvements. BCPA continues to raise funds through a variety of means including seat-naming sales to the community and procurement of gifts from individuals, corporations, foundations and other government sources. BCPA advises that more than \$3.7 million in "asks" are in front of investors pending decisions. BCPA anticipates continued fund raising through 2020.
