# **Briefing Items**

2. <u>18-0413</u> Environmental Action Plan Year Two Progress Report [Kristi Lynett, Office of Environmental Policy and Sustainability]

At approximately 4:33 p.m., Jim Parvey, Environmental Services Division Manager, Office of Environmental Policy and Sustainability, made opening remarks and provided an overview of the report, including examples to understand target graphics. Kristi Lynett, Sustainability Officer, Office of Environmental Policy and Sustainability, presented an overview of the target point for actions, including where the target goals met or were exceeded, where target goals were not met, action areas and statuses, stakeholders and advocates involved, transportation targets and actions, fuel reduction policy, material management target and actions, natural systems targets and actions, air quality and local foods, and climate resiliency. Ms. Lynett then presented on equity throughout the development of this plan and next steps.

Discussion ensued throughout on community solar goals, involvement of the Sustainable Tacoma Commission, City employees living within the City limits, electrical car data from 2016, bicycle infrastructure, an update on green roads policy and program, and threshold for future capital projects.

#### 3. <u>18-0414</u> Tree Planting Policy/Urban Forestry

Urban Forestry]

At approximately 5:00 p.m., Mr. Parvey made opening remarks and introduced Mike Carey, Management Analyst III, Office of Environmental Policy and Sustainability, and Rae Bailey, Division Manager, Public Works. Mr. Carey presented an overview of urban forestry, including conditions of a healthy urban forest, benefits of trees to the environment and health, statistics of green spaces, community health and safety improvements, economy benefits, the decline of Puget Sound forests, and the impact of urban tree canopies. He reviewed the adopted policies, including the Urban Forest Policy Element and the Environmental Action Plan, City tree canopy coverage and comparisons to other jurisdictions, urban forest resources involved, Tacoma Municipal Code examples related to tree planting policies and urban forestry, tree responsibilities in the City, and resident concerns regarding trees. Mr. Parvey concluded on next steps.

Discussion ensued throughout on reasons behind the decline of Puget Sound forests, progress of "30 by 30", urban forestry funding and staffing, comparisons to other jurisdictions and consistency, tree removal process, tree protection standards, City budget for hazardous trees, involvement of Code Enforcement, funding, next steps, and overall goals.
