Chair McCarthy called the meeting to order at 10:06 a.m.

Briefing Items

1. <u>18-0518</u> Green Jobs in the greater Tacoma area [Joel Baker, PhD, Science Director, Center for Urban Waters]

At approximately 10:06 a.m., Joel Baker, Ph.D., Science Director, Center for Urban Waters, University of Washington Tacoma (UWT), made opening remarks and presented a background on the Center for Urban Waters. Mr. Baker discussed the collaborative environment, history, key elements and foundation, education and workforce development, Urban Waters Summer Internship Program, growth of Science Technology Engineering Mathematics (STEM) degree programs at UWT, and the Readiness Acceleration Innovation Network (RAIN) Program. Jim Parvey, Environmental Policy and Sustainability Division Manager, Environmental Services, presented on the green jobs grant through the Local Employment and Apprenticeship Program, and Environmental Workforce Development and job training programs. He discussed the Innovation Partnership Zone (IPZ), including partnerships, major accomplishments since IPZ designation, connections, and strategies going forward. Ryan Vogel, Co-Founder and Executive Director, PureBlue, presented background information on PureBlue and blue tech companies. Connie Bacon, Commissioner (retired), Port of Tacoma, gave background information on early planning, ideas for the branding of Tacoma, and what role the City can play in supporting Urban Waters.

Discussion ensued throughout regarding wages earned through the job training programs, logistics of STEM degree programs, and the RAIN Program. Discussion continued on community and technical college involvement, building pipeline for engineering students, goals to translate jobs into economic opportunities, opportunities for networking events, growing new jobs, how to connect to job training, and career paths for entry-level jobs. Discussion continued on where PureBlue partnerships are located, assets in Tacoma and Washington that attract blue tech companies, opportunities for academic partnership, and career paths for entry-level jobs. Discussion concluded on out of state students conducting research in the City, policy decisions, workforce development, grants, opportunities to create more partnerships, and what role the City can play in supporting Urban Waters.
