## **Briefing Items**

1. 18-0391

Review of Participatory Budgeting
[Katie Johnston, Budget Manager, Office of Management and Budget]

At approximately 10:06 a.m., Katie Johnston, Budget Manager, Office of Management and Budget, made opening remarks and provided a description of participatory budgeting.

Council Member Blocker arrived here, at 10:07 a.m.

Ms. Johnston presented the process goals, community engagement, approach, intent of the process, comparison to other jurisdictions, funding processes, resources needed, lessons learned, and key questions. She then introduced Jacques Colon, Health Equity Coordinator, Tacoma-Pierce County Health Department. Mr. Colon provided examples of participatory budgeting in schools, lessons learned, boundaries set around the process, improvements of quality of life in schools, grant funding, staff time involved, and end goals. Ms. Johnston concluded on the human service contracting and city budgeting process, goals set by Neighborhood Councils, feedback from the community, alternative approaches, and next steps.

Discussion ensued throughout regarding other jurisdictions and their stake in

City government, education and understanding of budget, staff initiative, different examples to set priorities, grant funding, staff time involved, community engagement factors, timeline for the participatory process, Neighborhood Council involvement, alternative approaches, allocation of budget, and next steps.
