BACKGROUND:

The Government Performance and Finance Committee will consider letters of interest at a special meeting on Thursday, July 19, 2018, and may provide recommendations. The names of the individuals recommended for appointment will be considered by Resolution at the City Council meeting of July 24, 2018.

Per RCW 29A.32.280, for each measure from a unit of local government that is included in a local Voters' Pamphlet, the legislative authority of that jurisdiction shall, not later than forty-five days before the publication of the pamphlet, formally appoint a committee to prepare arguments advocating voters' approval of the measure and shall formally appoint a committee to prepare arguments advocating voters' rejection of the measure.

ISSUE:

Individuals need to be appointed to serve on the "Against" Committee and submitted to the Pierce County Auditor by Tuesday, August 7, 2018.

FISCAL IMPACT:

There is no fiscal impact.

RECOMMENDATION:

Staff requests that the Government Performance and Finance Committee recommend additional individuals to serve on the "Against" Committee to prepare statements "against" Proposition No. 1.
