# **Dear Mayor and Council Members:**

### ITEMS OF INTEREST

- 1. As you travel home from Tuesday's City Council meeting, you will notice many street closures throughout the City. These block parties or street closures are neighbors getting together celebrating "National Night Out." Tacoma citizens will join millions of people across the country on Tuesday for this annual event. Please see the attached list of neighborhoods participating.
- 2. Public Works Director Kurtis Kingsolver provides the attached memorandum with details about the final outreach efforts to current residential parking permit holders to assist them in transitioning to the new Residential Parking Program that begins late October 2018. Parking Services has worked to ensure existing permit holders were informed of their options during a 24-month transition assistance period that began October 2016, and to assist them in completing applications for the new program.
- 3. **Economic Development Update Report** Please see the attached memorandum from Community and Economic Development Project Manager Pat Beard regarding the status of **Topgolf and their proposal for the Tacoma Dome Site**. Topgolf hopes to develop a destination entertainment venue on 10.6 acres comprising of Tacoma Dome Lot G and adjacent parcels owned by Environmental Services. Parking, circulation and access for the Tacoma Dome studies are expected to be completed in December, followed by a discussion of next steps between the City and Topgolf.
- 4. The August 8, 2018 Public Utility Board meeting agenda is attached for your information. Please note item U-11020, which authorizes execution of a letter of agreement negotiated between the City of Tacoma and the International Brotherhood of Electrical Workers, Local 483, Click! Unit.

At Tuesday's Study Session, there will be a Municipal Court presentation on a pilot project to assist defendants experiencing mental health and homelessness by providing continuity of care and other supports to individuals in the criminal justice system. The services will engage, support and facilitate the stability of individuals, and support efforts to reduce recidivism and increase individual and community safety.

As a second item on the Study Session agenda, Office of Management and Budget will provide a **Second Quarter Financial Update with an actuals report**, including initiative tracker and performance management.

## **COUNCIL REQUESTS/INQUIRIES**

7. At last Tuesday's Committee of the Whole, staff received two requests from the City Council for follow up. One from Council Member Mello on the current tax rates, revenues, and maximum tax rates for Business and Occupations Tax (response attached).

In addition, Council Member Mello requested a breakdown of the City's non-voted and voted debt capacity including the reserve levels, current debt, and remaining capacity. The attached document shows the City's debt capacity as a function of the total taxable property value (\$23.2 B in 2018). The table then breaks out the non-voted limit of 1.5% of the total property value (\$350 M), minus the total non-voted General Obligation bonds (\$230 M) and the remaining required reserve (\$40 M). This leaves the available non-voted debt capacity of \$80 M. It also leaves the City's remaining voted general-purpose tax capacity, which is 2.5% of the total taxable value (\$580 M) less the voted and non-voted debt. Since the City has incurred \$230 M of non-voter approved debt and \$11 M of voter-approved debt, the voted debt capacity is \$339 M.

### **GRANT APPLICATION**

- 8. The City applied for the following grant:
  - Edward Bryne Memorial JAG Program FY18 Local Solicitation The
    City and Pierce County are federally declared disparate jurisdictions and
    eligible for this grant, which if awarded will be split equally. The City's
    funding would be for Tacoma Police and Neighborhood and Community
    Services to share equally to address criminal activity, strengthen
    neighborhoods, engage underrepresented populations, address
    community priorities, and coordinate supportive services. If awarded, the
    City's portion would be \$147,649 with no match required.

## **GRANT AWARD**

- 9. The City received the following grant award:
  - FY 2017 Assistance to Firefighters Grant Funding to purchase light weight personal protection equipment (PPE) washers/extractors. This equipment will be installed at 15 locations (fire stations, Training Center and Fire Prevention Center) and cover all the locations that do not currently have the ability to clean PPE on site. The <u>award was for</u> \$24,955, with a City match of \$2,495 required.



Update on Residential Parking Program Sunset Outreach

The Public Works Department, Parking Services, will oversee a final sunset notification to current residential parking permit holders that will become non-conforming on October 16, 2018, resulting from the new Residential Parking Program (Program) adopted by Ordinance No. 28383 on October 18, 2016. The Program has new procedural requirements and criteria for creating and maintaining a Residential Parking Zone (RPZ).

Parking Services recognized that the transition to the Program would require an extended period to inform the existing permit holders of the change. Parking Services deployed a 24-month assistance plan that began October 18, 2016, to assist applicants with the new RPZ. To ensure existing permit holders are well informed of the remaining time to complete the RPZ application, Parking Services is conducting one final outreach campaign via certified mail the week of July 30, 2018, informing current permit holders of their options.

Over the last 18 months, current permit holders received four notifications of the change and have been offered staff assistance to facilitate the application process. To date our efforts have included:

- Notifications mailed to all permit holders, property owners and property management offices in November 2016, January 2017, April 2017, and October 2017;
- A total of 2,200 notifications mailed to properties within the current RPZs; and
- 300+ email exchanges.

The affected current permit holders fall into two groups:

Group A: Properties that are eligible due to appropriate land use zoning, but must reapply before the sunset date to participate in the new Program. If they do not reapply, the old RPZ will be removed. In the event that staff receives an application before October 16, 2018, the old zone will not be removed until the petition process runs its course. This group consists of 44 RPZs, 73 affected properties, and 307 addresses notified.

Group B: Properties that are ineligible for the new Program because their addresses fall outside of the Program's residential zoning requirements. The old RPZs will return to unregulated curbside parking after the sunset date. To assist residences that are ineligible under the new Program requirements, staff has partnered with Downtown on the Go! to identify and coordinate targeted outreach for available parking alternatives. These include use of ORCA passes, monthly off-street parking options, walking maps and Zip Car information. This group consists of 11 RPZs, 52 affected properties, and 149 addresses notified.


To date, staff has received 21 applications for RPZs under the new Program. Of these 21 applications, 11 are old RPZs transitioning to the new Program. It is anticipated that six

RPZs out of the 21 applications will complete the transition process before the sunset date of October 16, 2018.

With the final outreach campaign, there is an increased likelihood that the City Manager's Office may receive questions regarding the Program. It is suggested that all inquiries be referred to Parking Services in order to meet one-on-one, if needed, to address individual concerns. There are 51 RPZs located in Council District No. 2 and 27 RPZs located in Council District No. 3; however, Council District No. 1 also has RPZs that will be affected. Therefore, Parking Services will make plans to meet with the council members of those three districts to inform them of the changes to the Program.

RE: Status of Topgolf proposal for Tacoma Dome site

### Background:

In response to a City-issued RFP, on May 8, 2018 Topgolf USA, Inc submitted the sole proposal and deposit of \$800,000 required as part of the RFP. The company hopes to develop a destination entertainment venue on 10.6 acres comprising Tacoma Dome Lot G and adjacent parcels owned by Environmental Services.

City Council Members, the media and public have recently requested updates regarding the potential project described in the Topgolf proposal. This update responds to those inquiries for your information and information of the City Council Members.

#### Update:

City staff elected to pursue discussions with Topgolf, however since the company was the only proposer, the need for an Exclusive Negotiation Rights Agreement was deemed to be unnecessary. The City is entering a Right of Entry Agreement with Topgolf to allow them to conduct soils and other analysis to determine development feasibility.

A successful project necessitates allowing adequate access and parking for both Topgolf and the Tacoma Dome. CED, TVE, Real Property Services and the Parking Division are working with Topgolf to understand the best options regarding these issues.

The City and Top Golf will enter a Memorandum of Understanding and financially cooperate on studies:

- TVE had planned to conduct an analysis of current circulation and access for the Tacoma Dome. Topgolf will pay for an added scope to include their proposal to the study on access and circulation;
- 2) An analysis of options and costs for a shared parking structure to serve both Top Golf and the Tacoma Dome, and possibly other public uses, will also be conducted. Topgolf and the City will share equally in the cost of this study.

The parking and circulation studies are expected to be complete in December, following which the City and Topgolf will discuss next steps.

As provided in the Revised Code of Washington (RCW) Title 39 Chapter 36, the percentage limits for the various sections are layered cumulative totals. The total General Purpose Indebtedness cannot exceed 2.5% of the Total Taxable Property Value (PV); General and Utility Purpose Indebtedness cannot exceed 5.0% PV; and General, Utility and Open Space and Parks Facilities Indebtedness cannot exceed 7.5% PV. Non-voted General Purpose Indebtedness may be up to 1.5% PV only if Voted General Purpose Indebtedness does not exceed 1% PV. The limits for General Purpose debt cannot exceed 2.5% PV. However, Utility and Open Space Indebtedness may exceed 2.5% PV for the section and reduce the General Purpose Indebtedness available by an equivalent amount. In addition to limitations in RCW, the City's Finance Policy requires the maintenance of a reserve in the amount of 10% of non-voted debt capacity.
