7. 18-0890 Transportation Commission Work Plan
[Jennifer Kammerzell, Senior Engineer, Public Works; Justin Leighton, Chair,
Transportation Commission]

At approximately 4:35 p.m., Jennifer Kammerzell, Senior Engineer, Public Works, made opening remarks and introduced Justin Leighton, Chair, Transportation Commission (TC). Ms. Kammerzell provided background information on the TC and reviewed the Commission's 2017-2018 accomplishments. Mr. Leighton presented the 2018-2019 Work Plan, noting the Six-Year Transportation Improvement Program, Transportation Master Plan biennial amendments, Street Initiative progress reporting, TC initiatives, project participation, agency coordination, updates and TC coordination. He concluded with the Infrastructure, Planning, and Sustainability Committee directions and recommendations.

Council Member McCarthy arrived here, at 4:52 p.m.

Discussion ensued throughout regarding formal liaisons and staff attendance at the TC meetings and advisory groups. Discussion continued on the curb ramp application. Discussion concluded on bicycle infrastructure, noting connections and the Work Plan, the Safe Routes to School program, and a comparison to other jurisdictions.

6. <u>18-0889</u> Transportation Commission Interviews

At approximately 5:04 p.m., Susan Haigh, Acting City Clerk, stated the Committee will be interviewing seven applicants for five positions on the Transportation Commission (TC). Ms. Haigh informed the Committee that Jane Moore and Jacki Skaught are seeking reappointment and stated Ms. Moore was unable to attend the interview and has provided written response, and Commission Chair Justin Leighton is moving out of District No. 3 and there is an alternate option to reassign Mr. Leighton from the Council District No. 3 position to an At-Large position.

8. 18-0891 Traffic Light Synchronization Part 2
[Leigh Starr, Assistant Division Manager; Kurtis Kingsolver, Director, Public Works]

At approximately 6:09 p.m., Leigh Starr, Assistant Division Manager, Public Works, made opening remarks and provided background information on the Traffic Light Synchronization. Mr. Starr presented on impacts, noting environment, time and economy, and health and safety. He continued on signal timing engineering, noting signals per electrician and signals per engineer. He reviewed vehicle detection in ground, noting number of intersections and number of detections failed; aerial vehicle detection, noting number of intersections and number of detections failed; fisheye vehicle detection, noting benefits, number of intersections, and number of detections failed; and missing and broken detection, noting what the symbol means on a map, traffic impact, and count. Mr. Starr concluded with possible solutions, noting Pierce Transit routes and stops and scaled by ridership, and what it would take to fix problem areas.

Discussion ensued throughout regarding what street loops detect, possible solutions and problem areas.
