Chair Blocker called the meeting to order at 4:36 p.m.

Briefing Items

1. 18-1126 Neighborhood Council Program
 [Carol Wolfe, Supervisor, Community and Economic Development]

At approximately 4:36 p.m., Carol Wolfe, Supervisor, Community and Economic Development, made opening remarks; briefly explained the documents presented to the Council Members; and provided information on the Neighborhood Council Program, including an overview; background, including a timeline, updates since the last presentation, and outreach; issues; proposed revisions, including Sections 1.45.010, 1.45.020, 1.45.050, 1.45.060, and 1.45.070 of the Municipal Code and other potential changes; outreach process; partners; next steps; and recommendations.

Discussion ensued regarding feedback from the Neighborhood Council members, the need for the program to align with Tacoma 2025 goals, how the program is working in its current state, participatory budget, the importance of neighborhood engagement, difficulties in participation and outreach, the size of Neighborhood Council boundaries, the need for providing trainings such as Equity 101, the need for working with Planning and Development Services staff for planning purposes, the need for making the Neighborhood Council membership known to the public, provision of leadership and necessary trainings, accessibility, the need for creating an effective channel between the City Council and the Neighborhood Councils,

outreach methods used to invite the Neighborhood Council members to this Community Vitality and Safety meeting and the City Council study session, creation of subcommittees, and fiscal impact.

2. 18-1128 Rental Housing Code

[ChiQuata Elder, Landlord-Tenant/Crime Free Housing Coordinator; M'Balu Bangura, Risk Analyst/Civil Rights Investigator, Office of Equity and Human Rights; Debra Casparian, Deputy City Attorney, City Attorney's Offic]

At approximately 5:13 p.m., ChiQuata Elder, Landlord-Tenant/Crime Free Housing Coordinator, Office of Equity and Human Rights (OEHR), made opening remarks and explained the reasons why the title was changed from Tenant Protection Code to Rental Housing Code. Debra Casparian, Deputy City Attorney, City Attorney's Office, stated staff is proposing to extend the temporary Amended Ordinance No. 28508 once more to January 31, 2019, to change the title to Rental Housing Code and to amend the code under the Human Rights Commission section. Ms. Elder reviewed the proposed amendments, including the notice process, noting concerns from the public, impacts on tenants and landlords, and a two-tier alternative option. M'Balu Bangura, Risk Analyst/Civil Rights Investigator, OEHR, and Ms. Elder presented the changes to the tenant relocation assistance fund and other options. Ms. Elder further explained the proposed amendments, including Section 1.95.060 of the Municipal Code, relating to notice to increase rent requirements; Section 1.95.070, relating to distribution of information requirement, noting issues, feedback, sources available on the City's web page, and tenant rights and responsibilities; Section 1.95.080, relating to retaliation prohibited, noting the City's involvement; Section 1.95.090, relating to installment payments permitted, noting the revisions to two-month lease language; and Section 1.95.100, relating to compliance and enforcement, noting community feedback, education and outreach, and other corrections to already provided language. Ms. Elder stated staff is working on how to collect valuable data related to tenant/landlord issues and concluded by sharing concerns from the Rental Housing Association.

Discussion ensued regarding the need for including reasonable accommodations and disclosure of protected class violations to the distribution of information requirement; clarification on the two-tier approach; the need for studying what success looks like, how the City can review the status in the future, and how or when the Council will be receiving reports on this matter; and the repercussion for tenant violations. Discussion continued on provision of aid services during the appeal process, appeal fee, clarification on homeowners participating in AirBnB services, the importance of not penalizing homeowners who are responsibly addressing compliance issues, the importance of continually holding stakeholder meetings, fiscal

impact concerns on provided projections, and clarification on Section 1.95.060 regarding the notice process on rent increases. Discussion concluded on the relocation assistance fund.
