8	an amendment to the TMC, adopting the rate adjustments to the City's solid
9	waste service charges as set forth herein, is reasonable and necessary to meet

12	and financially viable solid waste utility system; Now, Therefore,
13	BE IT ORDAINED BY THE CITY OF TACOMA:


