1 2 3	A RESOLUTION related to collective bargaining; authorizing the execution of a three-year Collective Bargaining Agreement between the City and District Lodge #160, on behalf of Local Lodge #297 of the International Association of Machinists and Aerospace Workers, Rail Mechanics Unit, effective retroactive to January 1, 2018, through December 31, 2020.	
4 5	WHEREAS the City has, for years, adopted the policy of collective	
6	bargaining between the various labor organizations representing employees and	
7	the administration, and	
8	WHEREAS this resolution allows for the execution of a three-year Collective	
9 10	Bargaining Agreement ("CBA") between the City and District Lodge #160, on behalf of Local Lodge #297 of the International Association of Machinists and	
11		
12	Aerospace Workers, Rail Mechanics Unit ("Union"), on behalf of the employees	
13	represented by said Union, and	
14	WHEREAS the bargaining unit consists of approximately 16 budgeted,	
15	full-time equivalent ("FTE") positions, and	
16 17	WHEREAS the CBA will provide for a wage increase in each year of the	
18	agreement, and	
19	WHEREAS retroactive to January 1, 2018, wages for the bargaining unit	
20	will increase by 3 percent; effective January 1, 2019, wages will increase by	
21	3.6 percent, and the classification of Railway Shop Worker (CSC 7142) will	
22 23	receive an additional \$1 per hour at the top step; and effective January 1, 2020,	
24	wages will increase by 3 percent, and	
25	WHEREAS other changes include: (1) a change from a reimbursement to	
26	an annual allowance for safety related footwear, (2) an increase to the meal

reimbursement rate to \$15 per meal, (3) an increase to the rate paid for standby 1 assignments to \$3 per hour, and (4) employees hired after the ratification date of 2 the agreement will not be eligible for longevity pay, and 3 WHEREAS the Agreement also commits Tacoma Rail to withdraw affected 4 members from the Western Metal Industry Pension Fund ("WMIPF"), and assume 5 6 all withdrawal liabilities in accordance with plan procedures and applicable law, 7 which liabilities are estimated to be in a range of \$5,430,000 for a one-time 8 payment, or \$95,000 a year for 20 years, and 9 WHEREAS the final withdrawal liability will be determined by WMIPF and 10 presented in an estimate of withdrawal payment schedule following a formal 11 12 extrication notice to the trustees, and Rail has included an amount in its budget to 13 cover the projected annual payment amount, and 14 WHEREAS it appears in the best interests of the City that the CBA 15 negotiated by said Union and the City be approved; Now, Therefore, 16 BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TACOMA: 17 That the proper officers of the City are hereby authorized to execute the 18 19 three-year Collective Bargaining Agreement between the City and the District 20 Lodge #160, on behalf of Local Lodge #297 of the International Association of 21 Machinists and Aerospace Workers, Rail Mechanics Unit, effective retroactive to 22 January 1, 2018, through December 31, 2020, said document to be substantially in 23 24 the form of the agreement on file in the office of the City Clerk, including the 25 26
