ITEMS OF INTEREST

3. At the December 10th Tacoma Arts Commission meeting, the Arts Commission accepted the recommendations of the Arts Projects funding panel who convened on December 7th to review, rank and recommend **funding to 32 Tacoma organizations in support of 2019 public outreach projects in the fields of dance, craft, film, music, visual, literary, cross-disciplinary, and cultural arts.** The awards range in value from \$1,200 to \$5,000. Total arts projects funding for 2019 equals \$100,000.

Funded organizations include Asia Pacific Cultural Center, Barefoot Collective, Centro Latino, Channel 253 LLC, Children's Museum of Tacoma, Chinese Reconciliation Project Foundation, Classical Tuesdays in Old Town, Destiny City Film Festival, Dru Films, Fort Nisqually Foundation, Happy Fox Studio, Hilltop Business Association, Kareem Kandi World Orchestra, King's Books, Latinx Unidos of the South Sound, McKinley Hill Street Fair, Metropolitan Glass, Orchestral Recital Series of Tacoma, Peace Works United, Sister Cities Council Of Tacoma, Sixth Avenue Business District, Tacoma Arts Live, Tacoma City Ballet, Tacoma Concert Band, Tacoma Girls Rock, Tacoma Ocean Fest, Tacoma Refugee Choir, Tacoma Urban Performing Arts Center, Ted Brown Music Outreach, Vietnamese American Community Association, Washington State Historical Society, and Write253.

- 4. The Tacoma Arts Commission has recommended 21 pieces of visual art for purchase and inclusion in the Municipal Art Collection (pictures attached). Funding for this purchase comes from 1% for art funds associated with renovations to the Tacoma Municipal Building. The pieces were created by Tacoma-based artists Anida Yoeu Ali, Adika Bell, Jasmine Brown, Heather Cornelius, Becky Frehse, Tiffanny Hammonds, Lucia Harrison, Lourdes Jackson, Lisa Kinoshita, Morrae Martin, Nicholas Nyland, Chandler O'Leary, Gerardo Peña, Liz Pulos, Christie Rooks, Roberto Sanchez, Masahiro Sugano, Dion Thomas, William Turner, Angela Wales, and Grace A. Washington. Sixteen of the artists are not currently represented in the Municipal Art portable works collection. The artwork will be exhibited in public spaces within City Hall with a focus on the newly renovated City Council offices.
- 5. 10th Street Parking Tunnel Improvements In an effort to address public health and security issues in the downtown core, the City is currently engaged in making improvements to a stairway located adjacent to the Park Plaza North Garage. The project is a coordinated effort between several City departments including: Community and Economic Development, Neighborhood and Community Services, Public Works, and Tacoma Venues & Events. Work began this week and will continue into early 2019. Improvements include cleanup of the exterior and interior walls in preparation for art installation, transition of the space from a stairway to a combined stair and bicycle storage facility, and installation of ornamental gating. These upgrades should increase available bicycle storage in downtown and enhance the overall safety and security for all users of this space.

SUMMARY:

The purpose of this memo is to provide a recap of recent meetings with stakeholders and staff regarding the Mayor's Youth Engagement Task Force and provide recommendations for adjusting the initially proposed process to be more inclusive and better aligned to the intended purpose of the youth outreach.

BACKGROUND:

Across the country municipal leaders are discovering one of their greatest assets; the youth of their city. Increasingly youth are working with elected officials and city mangers to address the issues of local government. In recent years the uptick of youth engagement has shown that more young people are discovering their voice matters and that they can affect their community by being civically engaged. City leadership is finding that when they provide meaningful opportunities for youth engagement more youth participate and encourage their peers to do so as well. In addition to engaging the next generation of civic leaders, cities already using this approach have realized many of the following benefits.

- Increased support for city initiatives such as student government day—involving youth and their families in different aspects of city planning allows for stronger and well-informed partnerships.
- Improved policies and programs for youth youth driven policies and initiatives can better capture what works and doesn't work for their peers.
- Improved indicators of well-being civic participation and engagement foster productive attitudes into adulthood and increase the likelihood of voting, volunteering and becoming valuable members of the workforce.

Youth engagement is of growing interest to the City of Tacoma and has been championed by Mayor Woodards. Over the last five months, staff has gathered stakeholders and started building a process that would support a future Tacoma Youth Commission. The process initially proposed and moved forward in October was a youth-led task force of 16 members that would both have access to personal development lessons, and discuss topics to guide the City in designing the Tacoma Youth Commission.

Following a meeting on November 29th to review the 126 applications to task force, stakeholders identified the proposed process as restrictive and exclusive as it would require us to turn down another 110 youth interested in engaging with the City. Stakeholders proposed a way to engage all youth applicants to reach the City's goals of a commission and invite other organizations who could support and learn from a gathering of this many youths. After a follow up discussion on December 5th, staff worked with stakeholders to narrow the scope of their ideas to find a balance between more broadly empowering youth and creating a channel for youth voice in City business.



The new process would engage all of the youth who applied in a visioning process that still provides development opportunities and feedback for the City. The youth would meet once a month with an additional special facilitation in January by the Institute for Civic Discourse for about five hours on a Saturday for a total of seven meetings. Stakeholders and other organizations can participate as volunteers in all meetings and also provide discussion so they too may gain feedback from this body.

ISSUE:

Community stakeholders have identified youth voice and engagement as a priority for many organizations across Tacoma, and were in agreement that the process should be inclusive as possible. As they have become more involved and felt some ownership in the process they are committed to making something happen in this realm and are appreciative of the leadership and coordination of these priorities by the City and Mayor.

An appetite for a youth summit or county-wide engagement was brought up but have been excluded from this proposal as they can be discussed and funded after the new year when stakeholders meet January 10.

ALTERNATIVES:

As an alternative to this new proposal we could move forward with the initial proposal of a 16-member task force, or to disband the process to allow youth-led design of a Tacoma Youth Commission and establish one based on staff recommendations.

Modifications to the proposed format for meetings and lessons can also be considered to best fit the needs of the City and the stakeholders.

FISCAL IMPACT:

Initial estimates for the proposed task force of 16 youth members was a budget not to exceed \$5,000 which would cover food at meetings, public transit access, and assistance to those not near transit lines who could utilize rideshare services and be reimbursed.

For this expanded process it would no longer be feasible to provide reimbursement at the same level for up to 120 youth, but food and travel, as identified as the largest barriers to participation, can still be provided by the City. For public transit vouchers and food to be provided at 7 meetings the cost estimate would be a budget not to exceed \$10,000.

Stakeholders have verbally committed to providing some resources to support this process. They are willing to gather incentives and awards to give to participants, give time to facilitation and discussion meetings, and provide meeting space for convening in either TPS buildings, the Asia Pacific Cultural Center, or the Eastside Community Center.

In addition to the budget and meeting space staff has been working with "Next Move" to identify junior and senior students eligible for academic credit who can use these task force meetings as part of their hour count for completion. Staff will also work with "Next Move" to place students into City of Tacoma or partner organization offices

RECOMMENDATION:


With support from stakeholders to provide resources and a strong desire to elevate youth voice, I would recommend moving forward with the new expanded process that includes all 126 applicants and that the City provide \$10,000 budget for food and travel to address those barriers to involvement. Community partners would provide volunteer time, meeting space, and any other financial support or incentives.

ITEM/ISSUE PROPOSED FOR COUNCIL CONSIDERATION:

We ask for your support for the inclusion of the following item on the agenda at the earliest available meeting of the Study Session:

We respectfully request City Council concurrence approval of up to \$15,000 in Council Contingency Funds to increase the use of fine particle pollution air sensors throughout the City in order to educate and engage the public in air quality monitoring. These funds will be directed to the PSCAA to purchase the air sensors, provide consultation regarding the most optimal locations for pollution detection, and provide public education regarding air quality and the use of air sensors. The City Manager's Office will work with the PSCAA to identify members of the community to site air sensors, this effort will be a two-year pilot program, to be evaluated thereafter. The air monitors will provide real time measurement of air quality and will be available to the regional air monitoring network managed by the PSCAA. Increasing the number of air monitoring data collection points will increase the capacity of the community to better understand and inform how to address air pollution.

BRIEF BACKGROUND:

On November 13, 2009, EPA formally designated part of Tacoma (the Wapato Hills-Puyallup River Valley area) as 'nonattainment', meaning that the air quality does not meet (or "attain") federal health standards. Air quality in our community is influenced by our topography and the shape of our land, meteorology and weather patterns, and the sources of pollution located in our community. Industry, cars, trucks and ships emit fine particle pollution, but the biggest source of our wintertime pollution is wood smoke. Pollution from wood smoke reaches unhealthy levels on cold, clear winter days when air is trapped close to the land ("inversion" conditions) and there is little wind to blow the smoke away. Poor air quality affects everyone, but children, the elderly, and people with existing respiratory or cardiac health problems are especially at risk. The very tiny size of fine particle pollution allows it to be inhaled deeply in the lungs and even cross into the bloodstream, increasing the potential for health risks. Thanks to the efforts of Tacoma and Pierce County residents – complying with air quality burn bans and participating in a program to remove 5,000 old polluting wood stoves – air quality has significantly improved and EPA returned the area to 'attainment' status in 2015.

Monitoring air quality is essential to understanding and addressing air quality, and the Tacoma *airshed* is one of the most studied *airsheds* in the State. While robust air monitoring facilities have historically been expensive to buy, site and manage, new advances in technology and market conditions have yielded lower cost air sensors suitable for residential consumers to purchase and install. Currently, the PSCAA is piloting the deployment of 'PurpleAir' air sensors in a short-term North Kitsap winter study. In addition, the PSCAA is considering a future air sensor

residential loan program, and independently, the NE Tacoma neighborhood council has purchased air sensors to better understand air quality in the neighborhood. While these sensors primarily serve educational purposes, they can also provide reliable data for understanding air quality throughout our community. Once obtained, the information collected by the air sensors is shared and mapped with the 'Purple Air' website and may be utilized by the PSCAA to obtain additional information regarding air quality in a variety of locations.

While the City of Tacoma is not specifically responsible for managing local air quality, the City has a duty to better understand and improve community health. Further, community interest in air quality has grown, particularly as it relates to the impacts of industrial uses on the air quality in abutting neighborhoods. The timing is appropriate for the City to participate in helping to gather more information about air quality throughout the City. A relatively small investment in PurpleAir sensors will provide our community with more information about our air quality and improve our ability to further understand and positively impact air quality for all Tacoma residents. Community confidence in air quality and our ability to address air quality will be improved by gathering more information and the data collected will help better inform our community about the condition of our air. Installation and maintenance costs are included in the budget request.
