### **Background** Background

- 2014 Charter Amendment No. 5
  - City Manager has power to appoint and remove all officers and employees under Manager's jurisdiction
  - Amendment: City Manager director appointments to be confirmed by City Council
- Five Department Directors confirmed by City Council since City Manager Pauli appointed in 2017
  - City Attorney
  - Human Resources
  - Neighborhood and Community Services
  - Information Technology
  - Community and Economic Development

## SEAL CITY OF THE CITY OF THE COMA

#### Factors to Consider

- Time to Hire
  - Competitive job market, especially at executive level
  - Critical to preserve ability to move quickly in order to recruit top talent
- Proposing three tiered confirmation approach
  - Based on position and department impact on community
    - Public Safety
    - External Facing
    - Internal Facing

### Charter Language

Section 3.4 – The Manager shall have the power to appoint and remove, subject to the civil service provisions of this charter and except as otherwise provided in this charter or by state law, all officers and employees of the City under the Manager's jurisdiction, provided, appointments of department heads shall require confirmation by the City Council. The Manager may authorize the head of a department or office responsible to the Manager to appoint and remove subordinates in such department or office. (Amendment approved by vote of the people November 4, 2014)
