3. 19-0037 Non-Emergent Lift Fee Educational Outreach Update [Jim Duggan, Fire Chief]

At approximately 10:05 a.m., Jim Duggan, Fire Chief, Tacoma Fire Department (TFD), introduced Mike Newhouse, Assistant Chief of Operations, TFD, and Mary Hallman, Medical Services Officer, TFD, and made opening remarks.

Council Member Blocker arrived here, at 10:06 a.m.

Mr. Newhouse presented an update on the lift assist education and outreach,

including an overview; background; historical, current, and continued outreach regarding non-emergent lift assistance, case review, education about the proper use of 9-1-1, and upcoming visits with various skilled nursing facilities and assisted living facilities; and next steps, including internal education with TFD crews. Mr. Duggan concluded by reviewing details of Amended Ordinance No. 28550.

Discussion ensued regarding the idea to create a communication line from responses from the licensed care facilities to the TFD, outreach to Certified Nursing Assistant (CNA) training facilities for continual education, if lift assists are available at CNA training facilities and if they are trained on how to use them, and reviewing updates after implementation. Discussion continued on provider access to call logs and incident reports, and facilities' requests for more time to train staff before full implementation of the ordinance.
