RECOMMENDATION SUMMARY:

Tacoma Venues & Events (TVE) recommends a contract be awarded to Northwest Industrial Staffing (NWIS), Kent, WA, for Temporary Personnel Services for Tacoma Dome and Greater Tacoma Convention Center, in the amount of \$1,130,000.00, plus applicable taxes, for an initial contract term of two (2) years with the option to renew for one (1) additional two-year period, for a projected contract amount of \$2,260,000.00.

- **STRATEGIC POLICY PRIORITY:** Assure outstanding stewardship of the natural and built environment.
- Encourage and promote an efficient and effective government, which is fiscally sustainable.

Temporary personnel services are required to support full time City of Tacoma staff in TVE venues in the fulfillment of event requirements, to meet operational and contractual deadlines, and to maintain a safe and clean environment.

BACKGROUND:

ISSUE: Temporary personnel services are required to meet contractual obligations and deliver on client and citizen expectations in the Tacoma Dome and Greater Tacoma Convention Center. Existing TVE staff complement is insufficient to meet these demands, and due to the inconsistent, event-based nature of the need for additional personnel services, the hiring of full-time staffing to support these demands is not feasible.

ALTERNATIVES: The alternative course of action would be to not execute a contract with a vendor to provide temporary personnel services. This would negatively impact the ability of TVE to secure business and would restrict the quantity of business in its venues as existing TVE staff complement is not able to provide the volume of required, event-based work.

COMPETITIVE SOLICITATION:

Request for Proposals Specification No. PF18-0420F was opened December 4, 2018. Six (6) companies were invited to bid in addition to normal advertising of the project. Five (5) submittals were received, and three (3) of the five (5) responses were scored. Two (2) of the five (5) responses failed to comply with the Request for Proposals document and were deemed "non-responsive."
