

Non-Standard	A building or structure with minor code violations that lead to structural deterioration. Examples of non-standard issues include broken or missing gutters, peeling paint, or a broken window.	-Pursue provisional licensing on rental properties	2.01		
Substandard	A building or structure that can be occupied, but has code violations present that must be corrected. Examples of substandard issues include missing safety hand rails on stairs, broken windows, or a roof that needs repair.	-Send Notice of Violation -Issue civil penalties -Record Certificate of Complaint -Pursue provisional licensing on rental properties	2.01		
Derelict	A building or structure that may not be safe to live in, may be abandoned, or may not have utility services. Unfit	A building or structure that is structurally unsafe and must be repaired or removed.
