AMENDMENT NO. 1 TO CONTRACT

THIS AMENDMENT is made and entered into effective this 1st day of April, 2019 ("Effective Date"), by and between the CITY OF TACOMA, a municipal corporation of the State of Washington (hereinafter called the "CITY") and Tacoma Public Schools, (hereinafter called the "CONTRACTOR").

WHEREAS, effective January 1, 2019, CITY and CONTRACTOR entered into a Contract ("Contract") for recruitment and training of school-based mental health intervention teams (Exhibit A-1) and coaching to all Tacoma Public School staff on restorative justice (Exhibit A-2), and

WHEREAS the CITY and CONTRACTOR desire to amend the Contract in order to increase the compensation allowed under the Contract and add Tacoma Whole Child Advanced Tier Intervention Program Scope of Work (Exhibit A-3), and

NOW, THEREFORE, in consideration of the mutual promises and obligations hereinafter set forth, the parties agree as follows:

- 1. The sum authorized for services under the Contract is hereby increased by \$291,833.76 from \$617,836.00 to \$909,669.76.
- 2. Add a new Scope of Work detailing services for universal screenings and mental health interventions to students in 24 elementary school and two middle/intermediate schools in the Tacoma School District, attached as Exhibit A-3 to this Amendment, and incorporated herein.
- 3. All other terms of the Contract, together with all exhibits, are hereby ratified and shall remain in full force and effect, unaltered by this Amendment.

Should this Amendment be executed after the Effective Date noted above, all terms and conditions herein shall operate retroactively to Effective Date.

Payment Points

Contract compensation will be divided into the following payment points:

- Sixty-five percent (65%) of the budget will be distributed equally over the course of the contract period.
- Five percent (5%) of the budget will be allocated to common measures quarterly reporting. Payment points may be claimed after each quarterly report has been submitted.
- The remaining thirty percent (30%) of the budget will be allocated to payment points associated with clients served and service-related output goals. Payment points may be claimed upon completion of each milestone:
 - o 30% of ALL outputs met (clients served and service-related)
 - o 60% of ALL outputs met (clients served and service-related)
 - 90% of ALL outputs met (clients served and service-related)
