Economic Development Committee

Council Member Hunter provided information regarding Click! Network cable television services, and thanked Tacoma Public Utilities' (TPU) staff for their level of service and professionalism.

Council Member Ushka also provided information on the Code Enforcement Division of the Neighborhood and Community Services Department, that staff has worked on closing 971 unassigned cases, and thanked staff for their work. Council Member Ushka concluded by stating a community meeting will be held to discuss Sound Transit staging materials for the Hilltop Link expansion at 38th Street and Pacific Avenue, at the Eastside Community Center, on Saturday, January 12, 2019, at 1:00 p.m.
