Environmental Services Financial Policy Update [Mike Slevin, Environmental Services Director]

At approximately 10:01 a.m., Mike Slevin, Director, Environmental Services, made opening remarks and presented an update on the Environmental Services Department Policy, including backgroud; the strategy and mission plan; and changes to the policy, including affordability rates, increased operating cash, an added rate stabilization target, flexible pay-as-you-go funding, updated debt coverage, and a clarified cash investment policy.

Discussion ensued regarding the difference between the reserve fund versus the stabilization fund and the affordability rates.

Tacoma Water Wholesale Pricing and Policy Revisions
[Sean Senescall, Finance and Analytics Manager; and Lyna Vo, Utilities Economist,
Tacoma Water]

At approximately 10:10 a.m., Sean Senescall, Finance and Analytics Manager, and Lyna Vo, Utilities Economist, Tacoma Water, made introductory remarks and presented the wholesale pricing and policy initiative, including the percentage of wholesale sales and demand, the decline of water demand, and unmet capacity. Ms. Vo presented on modernizing the rate design, including current pricing, proposed pricing, and the potential impact to customers; how

the proposal represents a balanced approach; and the expected date for requesting recommendations from the Council. Mr. Senescall outlined the choices wholesale customers will have; the potential opportunity for revenue; and how to responsibility manage supply risk. He concluded by reviewing a timeline of upcoming initiative milestones and a request for feedback on the work done so far.

Discussion ensued throughout on the impact to customers, how rate charges are calculated, recommendations for the next presentation, provision of an example of a market-based pricing model for wholesale customers, and feedback already heard from the Tacoma Public Utility Board.
