Solid Waste Management Commingled Recycling [Lewis Griffith, Solid Waste Management Division Manager, Environmental Services]

At approximately 4:34 p.m., Mike Slevin, Director, Environmental Services (ES), introduced Lewis Griffith, Solid Waste Management Division Manager, ES, and Preston Peck, ES, and provided background information on the commingled recycling program in Tacoma, issues faced in the market today, and community outreach the Solid Waste Division has conducted.

Mr. Griffith presented the proposed actions, including limited recycling, partial recycling, maintaining full curbside recycling, and maintaining full recycling plus; community engagement; feedback demographics; feedback results; the health, equity and sustainability analysis; recommendations; and next steps.

Discussion ensued throughout regarding multi re-use facilities, the difference between the proposed actions, waiving the surcharge for low income customers, satellite versus curbside systems, rules for China

accepting recycling, the revenue generated by customers in the recommendation, and staffing opinions around glass boxes.
