AN ORDINANCE related to the vacation of City right-of-way; vacating the southerly 250 feet of Chandler Street, lying north of Center Street and south of a previously vacated segment of Chandler Street, to rectify encroaching improvements on both sides of the Vacation Area, and enabling these improvements to remain and serve the business operations of which they are a part; and adopting the Hearing Examiner's Findings, Conclusions, and Recommendations related thereto.
