3. <u>19-0579</u> Public Utility Board Interviews [Doris Sorum, City Clerk]

At approximately 10:01 a.m., Doris Sorum, City Clerk, informed the Committee they would be interviewing the final two applicants for the Public Utility Board who were unable to attend the interviews at the May 21, 2019 meeting, where the Committe requested to interview them in person. She stated that at the previous interviews the Committee interviewed Joseph Atkinson, Owen Dahl, Timmie Foster, Tom Hilyard, Tracey Hunt, and Ryan Luther. She concluded by stating there is one position open on the Board to serve a five-year term.

The Committee interviewed Matthew Philichi and Carlos Watson.

Discussion ensued regarding applicants' qualifications, representation on the Board, and the needs of the Board.

At approximately 10:19 a.m., Jenni Barrett, Operations Manager, Tax and License, presented the Tacoma Municipal Code (TMC) Title 6 amendments, including entertainment licenses and Sign Erectors. She provided an overview, background, issues, proposed revisions, outreach, next steps, and recommendations.

Discussion ensued regarding outreach to the business community, temporary entertainment licenses, examples of temporary events, and events in venues that serve alcohol versus those that do not.

MOTION: Council Member Hunter moved to forward the proposed amendments to the TMC Title 6 to the full City Council for consideration.
