SUMMARY:

The Neighborhood and Community Services Department (NCS) has embarked upon Phase II of the Equity, Diversity, and Inclusion Initiative to engage staff and the provider community in the implementation of strategies and practices that will lead to greater organizational Equity, Diversity and Inclusion (EDI). The goal of this work is to build capacity for ensuring equity in service delivery, decision making, and community engagement. NCS has engaged the services of Colemon and Associates as a partner and subject matter expert in the EDI field, to facilitate and guide the project's success. This briefing will detail the 2019 work plan and projected outcomes, presented by the project team.

BACKGROUND:

In 2017-18, NCS staff supported City-wide equity and empowerment goals by providing Equity 101 trainings for funded providers. Department staff also conducted organizational assessments of funded service providers, and delivered feedback for how to:

- 1) Develop policies and practices that drive organizational culture around equity, diversity, and inclusion (EDI)
- 2) Learn the basics of sound equity policies, and implement practices that are congruent with those polices
- 3) Focus on building agency staff and organizational competencies, and ensuring the inclusion of client voice in service delivery

In 2019-20, NCS is shifting the technical assistance model, to require that funded service providers engage in EDI efforts at a level matching their organizational capacity. This EDI approach has proposed three paths to support funded service providers' success:



- 1) The Equity, Diversity, and Inclusion Pilot (EDIP): This option will build a community of practice by assisting funded agencies to share innovations, efforts, and learn together in a community of peers who are already engaged in EDI process with their respective organizations.
- 2) <u>Formalize Equity, Diversity, and Inclusion (EDI) efforts:</u> This option will encourage and assist funded agencies to formalize EDI efforts in the workplace and with beneficiaries of their services.
- 3) <u>Capacity Building Assistance:</u> This option is for funded agencies to ensure that all are engaged in concerted efforts to address inequities and disparities, even organizations that have not yet invested time or financial resources in the process.

In addition, Colemon & Associates will review NCS funding processes through an equity framework and provide technical assistance to staff and the Human Services Commission, to ensure EDI is reflected in funding application processes and recommendations. The consultant will also facilitate an exploratory process to help the City and Metro Parks Tacoma deepen their partnership, and build capacity within that partnership to provide equitable service delivery.

ISSUE:

The NCS Equity, Diversity and Inclusion Initiative supports City-wide equity and empowerment goals. The results of this work will be to develop an NCS Equity Plan, that will align with equity-related goals, providing specific tactics, and metrics. In addition, Colemon and Associates will provide technical assistance to and facilitate the convening of contracted service agencies, to develop provider capacity to deliver equitable services.
