#### ITEMS OF INTEREST

- 2. The Office of Environmental Policy and Sustainability is proud to announce the upcoming graduation of the first class of our Environmental Services Certification Program on July 18th. This pilot program is a partnership between our EnviroChallengers and the Tacoma School District and is designed to prepare youth for entry level positions in Green Jobs. Recruitment for the program is focused on inclusion and diversity. Students are learning about Green Job opportunities, meeting workers and gaining hands on experience while earning industry recognized certificates. Students earn their CPR/First Aid, CESCL, HAZWOPER, Flagger, and OSHS cards and learn Chain of Custody and Sampling techniques. Students also earn an Occupational Education .5 credit towards graduation. These students are preparing to enter the growing Green Jobs labor market. On July 18th, 5:00 to 8:00 p.m., the students are graduating and you are invited. Please come to hear about their progress and show your support at the Science and Math Institute (SAMI) located at Point Defiance.
- 3. I am pleased to announce that the City of Tacoma has been recognized for its data-driven management and reporting efforts with a Certificate of Distinction by the International City/County Management Association. Certificates are based on established criteria and are awarded at three levels: Achievement, Distinction and Excellence. Recipients at all levels collect and verify data to ensure reliability, train staff in performance measurement, and report data to the public through budgets, newsletters, and/or information provided to elected officials.

Certificates of Distinction are awarded to those who also provide comparative and benchmarking information to the public, use performance data in strategic planning and operational decision-making, and share their knowledge with other local governments through presentations, site visits and other networking activities. Tacoma is among 19 jurisdictions receiving the Certificate of Distinction, and one of 63 recognized overall.
