1. 19-0662 South Sound 911 Governance Restructuring

At approximately 12:07 p.m., Steve Victor, Deputy City Attorney, presented the South Sound 911 (SS911) governance restructuring, including an overview, the need for a new governance model, the governance review process, why the Public Development Authority (PDA) model is proposed, key points about PDAs, current SS911 governance, the new model proposal, the PDA Board of Directors composition, proposed terms for board members, proposed supermajority vote items, supermajority voting, and next steps.

Discussion ensued regarding consideration by Pierce County and other jurisdictions.

2. <u>19-0663</u> Washington State Substitute House Bill 1406 Update

At approximately 12:23 p.m., Tadd Wille, Deputy City Manager, City Manager's Office, introduced Daniel Murillo, Housing Division Manager, Community and Economic Development, and together they presented the highlights of Washington State Substitute House Bill 1406, related to encouraging investments in affordable and/or supportive housing; the City Council actions required; and next steps.

Discussion ensued regarding the intent of the legislation and the benefits for the City, tax credit rates, how the funds may be used, the timeline of the legislation, finding a way for the community to weigh in, impacts on affordable housing, using the legislation for Local Improvement Districts, and the types of developers that can receive loans.
