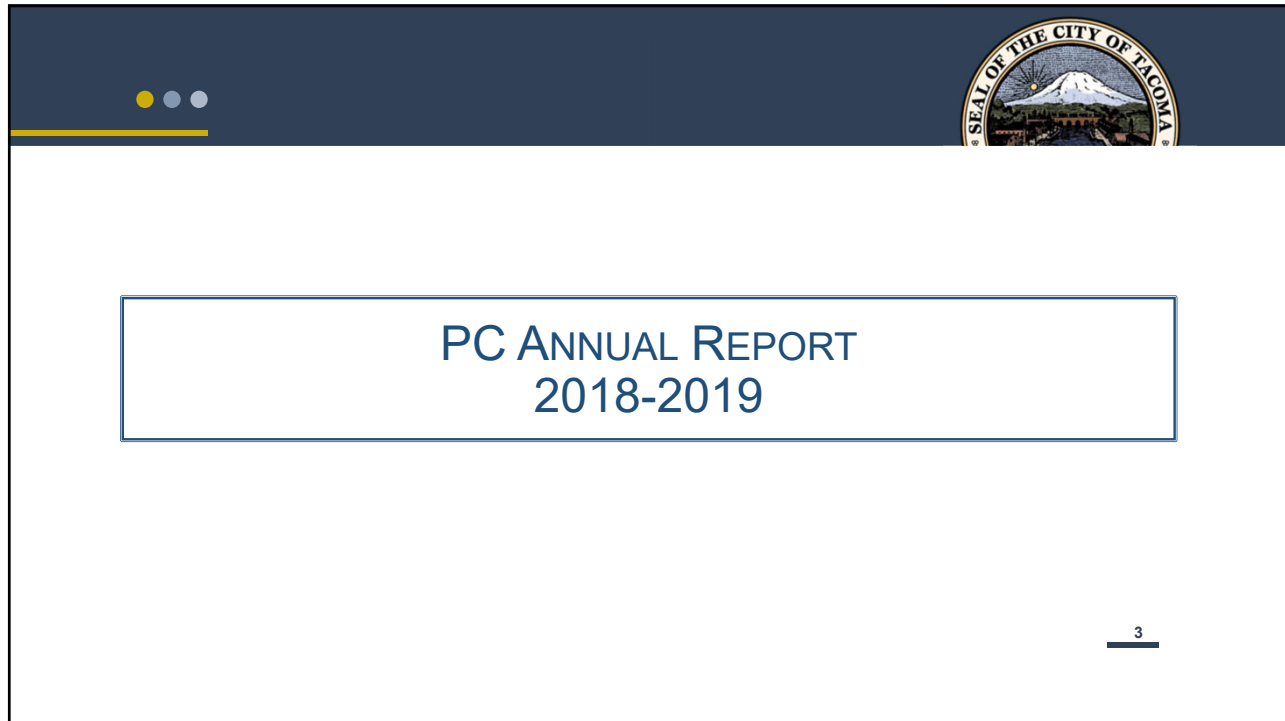

- Residential Infill Pilot Program – Implementation and project reviews

- Transportation Master Plan Implementation, in coordination with the Transportation Commission (e.g., Six-Year Comprehensive Transportation Program, impact fees study, transportation network planning, streetscape design guidance, signature trails development, etc.)
- Historic Preservation, in coordination with the Landmarks Preservation Commission (e.g. TDR, integration of Historic Preservation Plan with *One Tacoma* Plan, educational programs, etc.)
- Joint Meetings of the Planning Commission with appropriate groups (e.g., the Landmarks Pres. Commission, Transportation Commission, and Neighborhood Councils)
- Citizen Participation and Public Outreach Enhancements

REGIONAL & CROSS-JURISDICTIONAL ISSUES



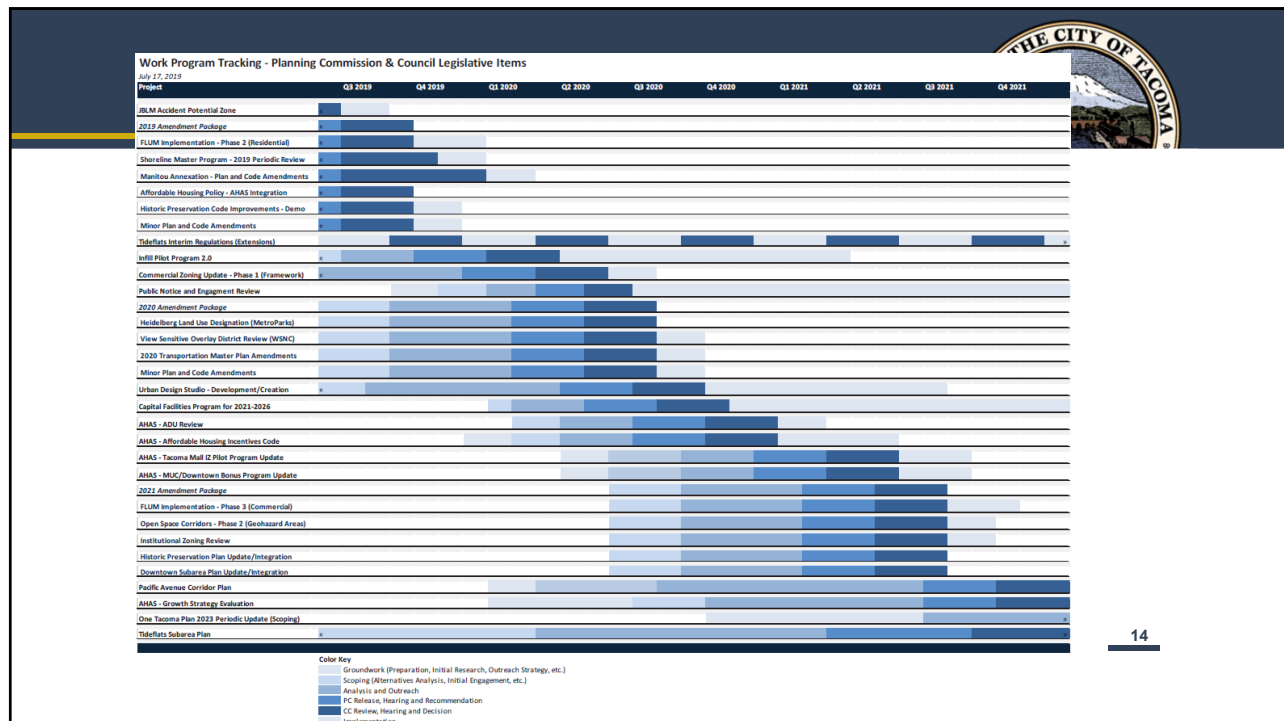
- Pierce County Parkland/Spanaway/Midland (PSM) Community Plan

- PSRC Regional Centers Framework Update, Vision 2050, GMA review, Buildable Lands
- PCRC County-Wide Planning Policies, County-level Centers Update

EMERGING & DEFERRED ISSUES

- Subarea/TOD Corridor Plans (Pacific, Portland, 19th, 6th, South Tacoma Way, etc.)
- Neighborhood Planning Program, including MUC Master Planning/Revitalization Strategies (Proctor, Narrows, McKinley, etc.)
- FLUM Implementation: Area-wide Rezones (Commercial Phase)
- Station Area Plan – Portland/I-5 Area
- View Sensitive District – Comprehensive Review
- Comprehensive Parking Requirements Review (RPA, refinements along light rail, Mixed-Use Centers, design, etc.)
- Increase Neighborhood Connectivity
- Connect south of I-5 to north of I-5 with bike/pedestrian infrastructure
- Infill development focus (complete business districts)
