SUMMARY:

The Tacoma Employees' Retirement System Director/Chief Investment Officer has been asked to appear before the GPFC to discuss Environmental, Social and Governance (ESG) issues related to the System's investment portfolio.

BACKGROUND:

This topic was previously addressed at GPFC meetings on June 5, 2018 and December 11, 2018.

Council Resolution 40273 urged, "Tacoma Employees' Retirement System ("TERS") staff and the TERS Board of Administration to consider/analyze the investment risks from climate change, and explore ways to potentially reduce exposure to carbon intensive companies, such as fossil fuel producers, in TERS' investment portfolio, subject to the TERS staff and Board continuing to meet their primary fiduciary responsibilities to TERS members."

TERS first established a Board Policy on this issue in 1985, with more recent Policy updates occurring in 2014 and 2017.

ISSUE:

TERS' \$1.8 billion trust fund is maintained to support current and future retirement benefits for the System's 3000 active members and the 3000 deferred/retired members and beneficiaries. The assets are overseen by the TERS Board of Administration, who has a fiduciary duty to act for the exclusive benefit of the plan participants and to administer the plan efficiently and properly.
