## COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

Economic Development Committee

Council Member Thoms, Chair of the Economic Development Committee, reported at the September 24, 2019 meeting, the Committee received presentations on Tacoma Public Utilities Economic Development Strategic Plan and the sidewalk café pilot. He stated the October 8, 2019 meeting was cancelled, and the next meeting will be held on October 22, 2019 and will include a presentation on the commercial office space incentive proposal.

#### Community Vitality and Safety Committee

Council Member Blocker, Chair of the Community Vitality and Safety Committee, reported at the September 12, 2019 meeting, the Committee interviewed one applicant for the youth position on the Commission on Disabilities who was appointed last week, and received a presentation on the state of Black Tacoma. He stated at the September 26, 2019 meeting, the Committee received presentations on the closed captioning ordinance and an ordinance updating the Neighborhood Council Program; and the October 10, 2019 meeting was cancelled. He concluded by stating the next meeting will be on October 24, 2019, and will include a presentation on policies for establishing shelters for homeless individuals.

Government Performance and Finance Committee

Council Member Ibsen, Chair of the Government Performance and Finance Committee, reported at the October 1, 2019 meeting, the Committee received a presentation on the Tacoma Employment Retirement System; and at today's meeting the Committee received a presentation on the 2017 accountability audit, the 2018 federal and single audit, and the 2018 entrance accountability audit. He stated the next meeting will be held on November 5, 2019 and will include presentations on Title 6 in response to House Bill 1403 and the Civil Service Board.
