RESOLUTION NO. 40464

A RESOLUTION related to collective bargaining; authorizing the execution of a 1 two-year Collective Bargaining Agreement between the City and the 2 Tacoma Joint Labor Committee, effective January 1, 2020, through December 31, 2021. 3 WHEREAS the City has, for years, adopted the policy of collective 4 5 bargaining between the various labor organizations representing employees and 6 the administration, and 7 WHEREAS this resolution allows for the execution of a two-year Collective 8 Bargaining Agreement ("CBA") between the City and the Tacoma Joint Labor 9 10 Committee ("Union"), on behalf of the employees represented by said Union, and 11 WHEREAS the Union is comprised of the following employees: Professional 12 & Technical Employees, Local 17 (PROTEC17); Tacoma Firefighters, Local 31; 13 Teamsters Local Union No. 117: Washington State Council of County and City 14 Employees, Local 120: International Association of Machinists & Aerospace 15 16 Workers, District 160; Teamsters Local 313; and International Brotherhood of 17 Electrical Workers, Local 483, and 18 WHEREAS the CBA provides for the continuation of employee benefits for 19 the term of the two-year agreement, and the City will continue to pay the full 20 premium cost for dental and vision insurance for eligible full-time employees, and 21 22 WHEREAS highlights of the proposed agreement include that in 2020. 23 part-time employees scheduled to work thirty (30) hours or more per week will 24 make benefit premium share contributions equal to those of full-time employees, 25 and in 2021, full-time employee premium share contributions for medical will 26



1	increase from \$40 to \$50 per month for employee only coverage, and from \$80 to		
2	\$100 per month for employee plus family coverage, and		
3	WHEREAS other changes to take effect in 2020 include: (1) adding		
4 5	out-of-network coverage at a 50 percent coinsurance rate for the Regence		
6	plans; (2) amending the Delta Dental plan to provide for a more common		
7	benefit structure that removes barriers to preventative care; (3) increasing		
8	the hardware allowance for the VSP vision plan to provide parity with what is		
9	offered under the Kaiser Permanente medical plan for vision benefits; and,		
10 11	(4) an increase to the meal allowance paid to employees from \$15 to \$18 per		
12	meal, except where an applicable CBA provides for a higher allowance, and		
13	WHEREAS it appears in the best interests of the City that the CBA		
14	negotiated by said Union and the City be approved; Now, Therefore,
