## **Briefing Items**

1. <u>19-1008</u> Level of Service Case Studies

At approximately 12:07 p.m., Nick Anderson, Management Analyst II, Finance, presented day four of the Capital Investment Strategy, including the study session work plan, agenda, best practices, and prioritization factors.

Justin Davis, Division Manager, Public Works Facilities Management, presented the repair and replacement program, level of service considerations, examples of repair and replacement for the Fire Communications center, the Beacon Center renovation, and the new Tideflats Fire Station.

Tory Green, Chief, Tacoma Fire Department (TFD), presented the standard of cover, including the definition of standard of cover, a key performance indicator example, and next steps for the TFD.

Kate Larsen, Director, Tacoma Public Library, presented the library feasability study, including a background, issues, the Request for Proposal

(RFP) Advisory Team, incorporating equity and sustainability in the RFP, an outline of the study, and next steps.

Katie Johnston, Budget Officer, Finance, presented the capital investment strategy wrap up, and next steps.

Discussion ensued throughout regarding relocation of the TFD, the age and condition of Tacoma's fire stations, and providing library services for disadvantaged communities.
