1. <u>19-1034</u> Tacoma Housing Authority Update

At approximately 12:13 p.m., Michael Mirra, Executive Director, Tacoma Housing Authority (THA) presented the THA update, including the Salishan neighborhood; Salishan home ownership and race; current apartment projects; building for seniors and persons with disabilities; Arlington Drive Campus for Homeless Youth and Young Adults; and THA projects in planning, noting the Hilltop Lofts, James Center North, and Hillsdale Heights Intergenerational Campus.

2. <u>19-1035</u> Internal Internship Program

At approximately 12:48 p.m., Gary Buchanan, Director, Human Resources (HR), made opening remarks and introduced Alice Phillips,
Business Manager, International Brotherhood of Electrical Workers,
Local 483; Cathy Journey, Senior Programs Manager, HR; and Tosha Siebert,
Relay Shop Supervisor, Transmission and Development. Ms. Journey
presented an overview, the Aspiring Leaders Portfolio, executive internship
program description, and key partners. Ms. Siebert presented her internship
experience, including exposure during the internship, thoughts and lessons
learned, and memorable takeaways.

3. 19-1045 Council Consideration Request- Neighborhood Engagement and Protection Standards for Construction Projects

Council Member Beale presented a Council Consideration Request (CCR) for a resolution directing the City Manager to review how the City engages the public and have staff bring results and recommendations related to neighborhood engagement and protection standards for construction projects to the Infrastructure, Planning, and Sustainability Committee.

Discussion ensued regarding public outreach, developer accountability, and concerns the CCR would address.

Council Member Ushka stated she will bring a CCR to a future meeting regarding the request for funds for a group in East Side putting on a Day of the Dead celebration.

Mayor Woodards gave an update on the Mayoral Roundtable on Affordabilty meetings that have occurred since August, as well as topics for the upcoming meeting on October 9, 2019.
