# **Briefing Items**

3. 19-1166 Review of Policies Establishing Shelters for Homeless Individuals
[Erica Azcueta, Program Manager, and Allyson Griffith, Program Manager,
Neighborhood & Community Services]

At approximately 4:42 p.m., Erica Azcueta, Program Manager, Neighborhood & Community Services (NCS), made opening remarks and presented background on the Municipal Code regarding shelters for homeless individuals, staff efforts and engagement since Ordinance No. 28498 was passed, and non-profit and faith-based concerns regarding required square footage for sheltering sites. Allyson Griffith, Program Manager, NCS, outlined each proposed change, including addressing the sector limitation and square footage threshold. Steve Victor, Deputy City Attorney, concluded by reviewing next steps.

Discussion ensued throughout regarding clarification of the proposal, the square footage threshold, and the sector limitation; concerns of sector limitations; temporary and emergency shelter criteria; inclement weather capacity; amenities that the City can help with; language of the temporary shelter ordinance; and the maximum number of shelters permitted within the City.
