
5. Discussion/Updates

a. Tacoma Arts Month Recap

Staff shared an overview of Tacoma Arts Month, including numbers drawn from the opening party, community calendar, and the Tacoma Studio Tour.

6. Staff Check In

a. Tacoma Creates 5:24 pm (16:55)

Staff presented an overview of Tacoma Creates updates: Participatory Budgeting, 54 Planning and Capacity Building Grants, getting the ordinance passed to turn the original initiative into law — a second reading by City Council will occur on December 3, planning for an advisory board with 12 seats.

Commissioners discussed and asked questions. There is concern that the application process for advisory board members, which will follow the same standardized process as all of the City's committees, boards, and commissions, will be intimidating and inaccessible for community members. Ideas to make the advisory board more accessible included: changing the structure of and time of the interview process, changing the times of meetings to not be right after work, changing the locations of meetings to different neighborhoods, providing funds or troubleshooting for transportation needs, providing childcare, providing stipends, increasing marketing and advertising to underrepresented groups and neighborhoods, extending the application and selection timelines.

b. Staff Projects Overview and Updates

Staff shared updates on the following projects: 58 Arts Projects applications are being processed, the panel will meet on December 4, and funding recommendations will be presented to the Commission at the next meeting.

The City Clerk's Office is offering quarterly trainings for boards and commissions, on ethics, 2025, and big picture things impacting the City overall. Commissioners are invited to attend but attendance is not required.

Staff presented a proposed Professional Development Series of classes and topics in response to the TAC Funding Subcommittee recommendations made in June 2019. Commissioners discussed and asked questions. There was encouragement that a cohort approach be considered to create a more connected group through these classes. Staff is also planning to continue Community Conversation events.

The Literary Laureate Subcommittee will be meeting later this month.
