*******BACKGROUND



Recent studies of food equity barriers on the Eastside

- In 2015 the Tacoma Pierce County Health Department prepared a Health Equity assessment
- In 2015 residents formed the East Tacoma Collaborative with the vision of a safe, healthy, thriving and equitable East Tacoma.
- In 2015, the Eastside Farmers Market was launched.
- In 2017-18 the City of Tacoma partnered with the UW and the Livable City Year Research project.
- In 2019, the City Council identified a Food Innovation District as one of their priorities at their February strategic work session.

- Warehouse/storage center
- Training center (skills and academic)







****FOOD INNOVATION DISTRICT

A Food Innovation District is a geographical concentration of food-oriented businesses, services, and community activities that local governments support through planning and economic development initiatives in order to promote a positive business environment, spur regional food system development, and increase access to local food" Michigan State University (2013)

*** DETROIT EASTERN MARK

- 240-acre district with 6-acre core market area
 - Restaurants
 - Shops
 - Food processors and distributors
 - · Twice-weekly retail farmers markets
- Detroit Eastern Market Corporation (EMC) manages it
- City of Detroit owns Eastern Market's assets and city leaders serve on the EMC Board



Pennsylvania – Fresh Food Financing Initiative

- · Public-Private Partnership
- Support supermarket and grocery stores in underserved urban and rural communities
- 88 fresh food retails
- · 5,000 jobs created
- 400,000 state residents have access to healthy foods
- · State invested \$30 million

Anaheim - Foodie District

- Grassroots dining district located at the old Packing House
 - 42,000 sq. ft. open air market place
 - 28 gourmet food and beverage vendors and merchants
 - Communal dining surrounded by cafes and kiosks
 - 2-acre Farmer's Park
 - · Live Entertainment Venue
- City invested \$10.4 million

- · Incubation/Acceleration
- Training programs

- Catering Services
- Immigrants and Refugees
- Individuals and institution donors

Staff will seek resources in the 2021-2022 budget to conduct a feasibility study of a Food Innovation District on the Eastside to include land use, transportation accessibility and site development potential leading to Food Innovation models for public/private investment.
