## **Briefing Items**

2. <u>19-1298</u> Citizen Police Advisory Committee Interviews [Doris Sorum, City Clerk]

At approximately 4:33 p.m., Doris Sorum, City Clerk, informed the Committee they will be interviewing three applicants and considering one written response from Phil Mocek, who was unable to attend the

interviews. She stated that Elizabeth Pew will not be interviewing, as she was recommended for appointment on the Tacoma Arts Commission, and provided information regarding vacancies on the Citizen Police Advisory Committee.

Council Member Ushka arrived here, at 4:38 p.m.

The Committee interviewed Alex Strautman and Gary Foreman, and reviewed one written response.

Discussion ensued regarding the number of vacancies; lack of representation from the "Council District 4", "Council District 5", and "Youth" positions; why applicants were not able to make the interviews; and having staff go out for more applicants.

MOTION: Council Member Ushka moved to recommend the reappointment of Alex Strautman to the "At-Large No. 3" position to serve a three-year term, effective January 1, 2020, to expire December 31, 2022.

3. 19-1299 Code Compliance Pilot Project Update
[Keith Williams, Code Compliance Supervisor,
Neighborhood and Community Services]

At approximately 4:51 p.m., Keith Williams, Code Compliance Supervisor, Neighborhood and Community Services (NCS), introduced Kristin Ely, Management Analyst II, NCS, and presented the Code Compliance Pilot Project update, including an overview, project outcomes, and case evaluation criteria. Together, they reviewed significant lessons learned, noting the top 15 list, the Yard Assistance and Resources for Disabled and Elderly (YARD) program, and House Bill 2057. Mr. Williams reviewed the number of preexisting cases that were closed and new cases that were opened and closed during the pilot project timeframe, positive outcomes, the goal to reduce the length of code compliance cases in 2019, improvements made to reach that goal, and next steps.

Discussion ensued regarding eligibility of YARD clients, how people found

out about the discount project, outreach, repeat offenders versus unique cases, expectation of future violations, discretionary actions while applying the nuisance and building code, whether the pilot program is budgeted to continue, receivership program breakdown and timeline, and property acquisition and rehabilitation.

4. 19-1300 Chronic Nuisance Code Implementation Update
[Danielle Larson, Tax and License Manager, Finance, and
Keith Echterling, Assistant City Attorney]

At approximately 5:25 p.m., Danielle Larson, Tax and License Manager, Finance, introduced Keith Echterling, Assistant City Attorney, and presented background regarding the Chronic Nuisance code and amendments made in October 2018. Mr. Echterling reviewed the implementation of the code, including one location that has been declared a "chronic nuisance property", engagement with that property, requirements, and properties that were considered for chronic nuisance code but not declared as such.

Discussion ensued regarding the nature of the calls for service, if noise qualifies as a nuisance violation, notifying new owners and potential owners of a chronic nuisance designation during property sales and potential property sales, an internal review process, and the correction agreement.

5. 19-1302 Co-Responder Program Update
[Shawn Gustason, Assistant Chief, Tacoma Police Department]

At approximately 5:44 p.m., Shawn Gustason, Assistant Chief, Tacoma Police Department (TPD), introduced Laura Morris, Program Director, Tacoma Fire Department (TFD), and presented the Co-Responder Program update, including implementation of the program, the development of the Designated Crisis Responders (DCRs), the contracted provider, and the merge of TPD mental health related calls and extended case management. Ms. Morris outlined how DCRs can become City employees and the State's response. Mr. Gustason reviewed the contract with MultiCare and the merge of TFD and TPD programs. Linda Stewart, Director, NCS, presented information regarding benefits of the collaboration, including the fiscal savings and effectiveness.

Discussion ensued regarding the safe station and the effect the merger will have on it, addressing community and patients' needs, how DCRs are embedded in TPD, and how the response team is related to the DCRs.
