## **RECOMMENDATION SUMMARY:**

The Public Works Department recommends a contract be awarded to Construct Incorporated, Tumwater, WA, in the amount of \$557,800, plus a 16 percent contingency, for a cumulative total of \$647,048, plus applicable taxes, for the Tacoma Municipal Building 5<sup>th</sup> floor tenant improvements.

# STRATEGIC POLICY PRIORITY:

- Assure outstanding stewardship of the natural and built environment.
- Encourage and promote an efficient and effective government, which is fiscally sustainable and guided by engaged residents.

This contract will provide for interior tenant improvements of the existing 5<sup>th</sup> floor office space in the Tacoma Municipal Building. The work includes, but is not limited to, selective demolition, interior framing and gypsum board installation, new interior finishes, casework, and mechanical and electrical systems.

## **BACKGROUND:**

ISSUE: The 5<sup>th</sup> floor of the Tacoma Municipal Building is currently occupied office space and has not undergone significant improvements since it was occupied in 1979. This contract will provide for the replacement of interior finishes and mechanical systems that are beyond their useful life, and provide for minor space modifications to improve workflow.

ALTERNATIVES: The alternative to the project is to take no action. Postponing this project will delay replacement of finishes and heating/cooling systems that are beyond their useful life as well as needed workspace improvements.

## COMPETITIVE SOLICITATION:

Request for Bids Specification No. PW19-0333F was opened November 19, 2019. One hundred and eleven companies were invited to bid in addition to normal advertising of the project. Ten submittals were received.

Construct Incorporated submitted a bid that resulted in the lowest evaluated submittal after consideration of Small Business Enterprise (SBE) participation goals. The table below reflects the amount of the base award.

CONTRACT HISTORY: New contract.

SUSTAINABILITY: Mechanical system improvements will increase energy efficiency. Products with recycled content and low-emitting materials such as paints and coatings will be used.

SBE/LEAP COMPLIANCE: The recommended contractor is in compliance with the SBE Regulation requirements per memorandum dated November 21, 2019. The SBE goal for this project is 22 percent and the SBE participation level of the recommended contractor is zero. Construct Incorporated submitted the lowest evaluated bid per the SBE Regulation requirements. The Local Employment and Apprenticeship Training Program (LEAP) goal is not applicable.
