#### JOINT MEETING WITH THE PUBLIC UTILITY BOARD

Mayor Woodards called the joint study session to order at 12:09 p.m.

Mayor Woodards provided opening remarks. Public Utility Board (PUB) Chair Larkin introduced the PUB Members.

# **Joint Executive Session - Pending Litigation**

MOTION: Council Member Ibsen moved to convene to Joint Executive Session pursuant to RCW 42.30.110(1)(i) to discuss pending litigation, not to exceed 30 minutes.

The Council and PUB convened to Joint Executive Session at 12:12 p.m. City Attorney Bill Fosbre; Chief Deputy City Attorneys Chris Bacha and Tom Morrill; and Deputy City Attorney Martha Lantz; City Attorney's Office; and Gail Karish, Best Best & Krieger LLP, were present.

The Joint Executive Session concluded at 12:42 p.m., and the joint study session reconvened at 12:45 p.m.

### **Briefing Items**

#### 1. <u>19-1139</u> Click! Updates

At approximately 12:45 p.m., Joanne Hovis, President, CTC Technology and Energy, presented the Click! update and analysis, including Click! history and analysis; policy goals; the 2017 to mid-2018 evaluative process; the 2018 request for information and qualifications to test a collaboration model; non-responsive proposals opportunity to revise; actions between August 2018 and the present, noting the stakeholder engagement process, key policy goals, and negotiations; and policy goals incorporated into agreements and exhibits, noting public ownership of assets, equitable access, low-income and affordable access, net neutrality, open access, preserving competition, safeguarding municipal use of services, maintaining financial stability, economical development and educational opportunities, job options for Click! staff, consumer privacy, and Click! goodwill and customer service.

Discussion ensued regarding plans for Click!, responsibility for technical equipment, and the Click! brand.

Deputy Mayor McCarthy arrived here, at 1:22 p.m.

Discussion continued regarding the future of cable television products, use of taxpayer money, the prices and speeds of competitor's products, Click! coverage, customer service goals, job options for Click! staff, and free access to community anchors.

At approximately 1:45 p.m., Jackie Flowers, Director, Tacoma Public Utilities (TPU), presented the Click! surplus, including backbone fiber makeup, network layout, and network ownership and operators.

Mr. Bacha presented the surplus declaration, surplused assets, proposed disposal, excess capacity, the reason for surplus, meaning of surplus, the effect of surplus declaration, operation in transition, and when disposal will occur.

Discussion ensued regarding policy goals and contract terms.

 19-1140 Cushman and Adams Substations Future Use Study and North 21st Street Tree Updates

At approximately 2:13 p.m., Clark Mather, Government Relations Officer, TPU, introduced Elliot Barnett, Senior Planner, Planning and Development Services, and Terry Coggins, Facilities Manager, TPU. Together, Mr. Barnett and Mr. Coggins presented the Cushman and Adams Substations Future Use Study and North 21st Street tree updates, including the street tree planting plan for North 21st Street, the Cushman/Adams study area, City Council and Board direction, policy framework, the future use study, the team, engagement approach, going from ideas to scenarios, timeline and milestones, and City Council and Board guidance.

Discussion ensued throughout regarding urban tree canopy maintenance past the first three years, understory planting, and alternatives to substations.

3. 19-1141 Classification and Compensation Study Update and Review of Draft Compensation Philosophy

At approximately 2:50 p.m., Gary Buchanan, Director, Human Resources, made opening remarks on the class and compensation study, and introduced Kari Louie, Senior Manager, and Jen Peters, Manager, Compensation and Benefits. Together, they presented the background, actions to date, what is happening now, the project timeline, the compensation philosophy review, overview of recommended philosophy, key changes from existing philosophy, and next steps.

Discussion ensued regarding history of pay inequity.

4. <u>19-1142</u> LEAP/SBE Workforce Development and Equity Contracting Recommendations

The joint study session recessed at 3:05 p.m.

The joint study session reconvened at 3:07 p.m.

At approximately 3:07 p.m., Clifford Armstrong, Program Manager, Community and Economic Development, and Steve Victor, Deputy City Attorney, City Attorney's Office, presented equity in contracting, including the agenda, desired outcomes, objectives, recommendations, outreach, code revisions, the advisory committee, and next steps.

Discussion ensued regarding how the cumulative annual goals are created,

race- and gender-based programs, using race and gender specific criteria, and public outreach.
