Call to Order

Deputy Mayor McCarthy called the study session to order at 12:10 p.m.

Briefing Items

1. <u>19-1228</u> Mid-Biennium Budget Modification Recommendations

At approximately 12:11 p.m., City Manager Elizabeth Pauli made opening remarks and presented the agenda and the purpose of the modification.

Mayor Woodards arrived here, at 12:13 p.m.

Ms. Pauli presented the 2019-2020 biennial budget priority areas and the Budget Initiative Tracker. Katie Johnston, Budget Officer, Finance, presented the modification highlights, noting affordable housing, homelessness, public safety, health equity, economic development, transit access, walkability, civic engagement, digital equity, health equity and equity, asset management, and government performance. She further presented the general fund adjustments, including general fund resources, general fund modification requests, and long term financial planning; and other fund adjustments, noting special revenue funds adjustments, enterprise funds adjustments, capital budget highlights, and important dates.

Discussion ensued regarding expanding the temporary shelter, the Tacoma Rescue Mission shelter expansion, recruiting and budgeting for the Tacoma Police Department (TPD), revenue contributions for the Tacoma Dome and Greater Tacoma Convention Center, translation services, inclement weather sheltering, faith-based organizations offering shelter, overtime funding for TPD patrols, and cleaning up trash and debris at

locations used as homeless encampments.

Other Items of Interest

2. 19-1229 Proposed Amendments to Ordinance No. 28624, Firearms and Ammunition Tax Discussion

Ms. Pauli stated that the proposed amendment to Ordinance No. 28624 would add language to exclude manufactured gun parts from the tax.

Discussion ensued regarding implementing a gun buy-back program, the amount of money the tax would generate, how much the City spends on gun violence prevention currently, City programs offered to intervene and/or prevent gun violence, and the intent and purpose of the ordinance.

3. 19-1247 Proposed Resolution directing the City Manager to convene a Gun Violence Reduction Workgroup

Council Member Hunter presented a proposed resolution directing the City Manager to convene a Gun Violence Reduction Workgroup comprised of representatives from Tacoma Public Schools, Tacoma-based firearms manufacturers and retailers, community partners, and City of Tacoma staff to reveiw approaches to address gun violence in the City that includes recommendations with fiscal analyses to be shared with the appropriate Council Committees by March 1, 2020.

Discussion ensued regarding getting manufacturers involved in prevention programs, the Executive Steering Committee and the Gang Project, and utilizing existing resources.
