Briefing Items

2. <u>19-1460</u> Moss Adams 2019 Entrance Conference [Susan Calderon, Assistant Director, Finance]

At approximately 10:02 a.m., Leda Voigt, Utilities Accounting Division Manager, Tacoma Public Utilities (TPU), introduced Olga Darlington, Partner, Moss Adams. Ms. Darlington presented the 2019 Audit Service Plan, including Service Team leads, required communications to those charged with governance, audit timing, scope of services and deliverables, planning and risk assessment, an explanation of materiality, the audit process, areas of audit emphasis, consideration of fraud, and communications.

Discussion ensued regarding new standards of testing, differences between the City audit and Pierce County audit, and releasing an announcement or statement regarding our audit process to highlight what the City is doing.

3. 19-1461 Affordable Housing Incentives
[Clark Mather, Government Relations Officer, Tacoma Public Utilities, and Peter Huffman, Director, Planning and Development Services]

At approximately 10:13 a.m., Peter Huffman, Director, Planning and Development Services introduced LaTasha Wortham, Government Relations Analyst, TPU; Debbie Bingham, Project Manager, Community and Economic Development; and Jennifer Hines, Assistant Division Manager, Public Works. Mr. Huffman presented an overview of the state of affairs regarding the City's current abilities to waive various fees, building and land use inspection fees, Planning and Development Services fee waiver budget, the amount of fee waivers to-date, projects that have been granted fee waivers, Tacoma Municipal Code fee waiver criteria, and history of the budget regarding the permit process. Ms. Wortham reviewed incentive information regarding utilities, including fee-for-service waivers, restrictions, how TPU addresses affordable housing in Tacoma, and a long-term tracking process. Ms. Bingham outlined the Multi-family Property Tax Exemption (MFTE). Mrs. Hines presented an update on the Affordable Housing Action Strategy Action Item 1.6, including improving coordination between Public Works and Utilities, ways to balance offsite improvement costs for affordable housing developers, a two-tier approach, and requirements.

Discussion ensued regarding a focused approach versus a broad approach, who pays the fees that are waived, fee waiver amount, presenting the affordable housing incentives information to the new Council Members, monitoring affordable housing to ensure they meet the requirements, penalties if requirements are not met, targeting nonprofit developers for affordable housing incentives, the financial model regarding the 8-year and 12-year MFTE, how for-profit and nonprofit developers begin projects, utilization of the fee waiver budget, and timeline.
