SUMMARY AND PURPOSE:

An ordinance relating to the Chronic Public Nuisance Code, amending Title 8.30A of the Tacoma Municipal Code (TMC), to remove "Domestic Violence" as a qualifying nuisance activity from the list set forth in TMC 8.30A.020, to protect victims from being deemed "nuisance" tenants for reporting criminal activity.

BACKGROUND:

<u>The Departments Recommendation is Based On</u>: Statistics and information provided by the Human Rights Commission, Policy and Advocacy (P&A) Committee members regarding "domestic violence" as a qualifying nuisance activity and how nuisance ordinances have been found to discourage reporting domestic violence to law enforcement and seeking emergency medical and police assistance.

COMMUNITY ENGAGEMENT/ CUSTOMER RESEARCH:

The P&A Committee provided information regarding federal, state and county law that all, in varying ways, protect victims of domestic violence form being deemed "nuisance" tenants and/or discriminated against in housing based on, or as a result of, their status as victims of domestic violence.

2025 STRATEGIC PRIORITIES:

Equity and Accessibility:

In an effort to support domestic violence victims' rights, the proposed amendment to TMC 8.30A will remove "Domestic Violence, TMC 8.105" from the list of nuisance activities as defined in section 8.30A.020.

Livability: Equity Index Score: Moderate Opportunity

Improve access and proximity by residents to diverse income levels and race/ethnicity to community facilities, services, infrastructure, and employment.

Removing "domestic violence" as a qualifying nuisance activity will protect victims of domestic violence from being deemed "nuisance" tenants and not punish victims for reporting criminal activity to law enforcement and risking eviction by their landlord.
