ITEMS OF INTEREST

- 2. The Planning Commission will conduct a public hearing on Wednesday, March 4th, 2020, at 5:00 p.m., in the Council Chambers, to receive public comment on the proposed Residential Infill Pilot Program regulations. The proposed changes are intended to implement improvements based on lessons learned through administration of Infill Pilot 1.0. The changes would expand infill housing types and number, modify design requirements and standards, and streamline the permit review process. The Commission is expected to forward its recommendations to the Council in late March for consideration for adoption in April 2020. Planning and Development Services Director Peter Huffman provides background and additional information in the attached memorandum.
- 3. Tacoma's Affordable Housing Action Strategy (AHAS) calls for creating diverse and affordable housing as one way to address pressing housing challenges. Through 2020, Tacoma's Planning Commission is asking the community to join in a discussion about housing needs, development trends, zoning, and neighborhood change. The Commission is now seeking public input on its proposed scope of work. On Wednesday, March 5, 2020, at 5:00 p.m. in Council Chambers, the Planning Commission will conduct a public hearing to receive comments on proposed changes to the Residential Infill Pilot Program regulations intended to make the program more effective. The Commission is expected to forward its recommendations to the City Council in late April for consideration for adoption before the end of the year.

BACKGROUND

In December 2015, the City Council established the Residential Infill Pilot Program, as part of a package of Affordable/Infill Housing code updates. The intent of the Pilot Program is to promote innovative residential infill that demonstrates high quality building and site design. The following infill housing types were reviewed under the Pilot Program:

- Detached Accessory Dwelling Units (DADUs) in single-family zoning districts
- Two-family development on corner lots in the R-2 Single-family district
- Small-scale multifamily development in the R-3 district
- Cottage Housing in most residential districts

The Pilot Program allows a maximum of three of each infill housing type to be developed (potentially up to 12 projects in total).

Since the Pilot Program was rolled out in 2017, the City has accepted a total of eight projects (three DADUs, three Two-family, and two Cottage Housing developments) through the Pilot Program. In March 2019, the City Council change the rules for DADUs, allowing them more broadly in single-family zoning districts and removing them from the Pilot Program.

The Planning Commission is now seeking input on recommended code changes intended to make the Pilot Program more effective. The proposed amendments to several sections of the Tacoma Municipal Code, Title 13 – Land Use Regulatory Code, would implement the following changes:

- Expand the program with a new Density-based Housing infill category and increase the number of each housing type allowed through the program
- Modify standards and design requirements to improve design outcomes, clarify the process, ensure consistency with the Building Code, and increase flexibility for the Cottage Housing and Two-family Housing types
- Streamline the permit process by integrating the Pilot Program review process into the Conditional Use Permit process (rather than requiring both separately)

Pending Council action, Planning and Development Services will update the Pilot Program handbook to reflect changes and enhance design guidance, then re-open the Program for applications. Staff anticipate Infill Pilot 2.0 will be up and running in June 2020.
