## **SUMMARY:**

- Appointing Patrícia Flores to the "Alternate" position for a term to expire March 31, 2022.
- Reappointing Diana Parra to serve a three-year term, effective April 1, 2020, to expire March 31, 2023.
- Reassigning Perla Gamboa-Ravelo from the "Alternate" position to a "Member" position for a term to expire March 31, 2022.
