SUMMARY:

- Appointing Patrícia Flores to the “Alternate” position for a term to expire March 31, 2022.
- Reappointing Diana Parra to serve a three-year term, effective April 1, 2020, to expire March 31, 2023.
- Reassigning Perla Gamboa-Ravelo from the “Alternate” position to a “Member” position for a term to expire March 31, 2022.

STRATEGIC POLICY PRIORITY:

As the Commission shall have the duty and power to study problems and issues specifically impacting the immigrant and refugee communities, appointing individuals to the Commission best aligns with the strategic policy priority related to furthering immigrant and refugee access to and participation in Tacoma’s economic, cultural, and civic life.

BACKGROUND:

A vacancy on the Commission occurred, automatically reassigning Perla Gamboa-Ravelo, the “Alternate” into a “Member” position, to be confirmed by the full City Council. Additionally at the February 27, 2020 Community Vitality and Safety Committee meeting, the Committee conducted interviews and recommended the appointment and reappointment of the individuals listed above.
