2. <u>20-0101</u> City Insurance Program

At approximately 10:01 a.m. Andy Cherullo, Director, Finance, introduced Saada Gegoux, Risk Manager, Finance, and Kim Wilson, Vice President, Brown and Brown Insurance. Ms. Gegoux presented the City's insurance program, including insurance policies purchased; the self-insurance program, noting general liability, law enforcement, and workers' compensation; insurance factors, noting industry rates, claims history, and claims analysis;

2019 annual insurance premiums; and cost distribution of premiums.

Discussion ensued throughout regarding City-owned drones, fiduciary liability, general liability, funds that cover claims, large claim payouts being approved by the City Council, self-insurance fund balance, and the number of claims and expenditures for pothole damages and trip and falls.
