REPORTS BY THE CITY MANAGER

City Manager Elizabeth Pauli expressed her appreciation for City staff and introduced the Emergency Management staff, including Tory Green, Chief, Tacoma Fire Department (TFD); Ute Scofield, General Government Emergency Director, TFD; and Courtney Rose, Public Utilities Emergency Director, Tacoma Public Utilities (TPU).

Chief Green provided an update on the City's response and involvement regarding the COVID-19 emergency, including the Emergency Coordination Center being fully activated, joint collaboration between General Government and TPU, daily briefings, documenting action plans, implementing work-from-home practices, establishing a workgroup to create a County-wide strategy to address the unhoused, and working to establish a drive-through testing site in Tacoma.

Discussion ensued regarding the testing site, quarantine and isolation facilities, criteria for who receives testing, other testing options, a quarantine timeline, communication on testing, personal protection equipment (PPE), and plans for exposure for emergency responders.

City Manager Pauli provided an update regarding precautionary measures and administrative actions taken in response to the COVID-19 pandemic and answered questions from constituents.

Jackie Flowers, Director, TPU, provided an update on continued internet service.

Jeff Robinson, Director, Community and Economic Development (CED), provided an update on what CED is doing to mitigate impacts of the COVID-19 pandemic on the business community, including information gathering, a website of resources, planning for microloans, technical assistance for small business, removal of penalties related to business and occupation job tax credit, and due date adjustments.

Mayor Woodards provided information on the Economic Development Board.

Linda Stewart, Director, Neighborhood and Community Services (NCS), provided an update on how NCS can address current needs, including providing payment to landlords in the form of rental assistance, supporting existing service providers, expediting payments, providing additional assurance for future funding for existing and new providers, altering the application process, assisting shelter providers, responding to encampments and aiding in medical connections when needed, and extending outreach.

Discussion ensued regarding medical assistance to individuals in encampments, criteria for testing, PPE for service providers, setting up sheltering locations, and available resources for childcare.

City Manager Pauli reported that the City has temporarily suspended ticketing for overtime parking violations, and public access to services, such as permitting, will be closed but will continue remotely.

The Mayor and Council Members expressed appreciation and gratitude for staff and partners in providing support and services during this emergency and the importance of keeping communication lines open.
