A RESOLUTION relating to stormwater systems; authorizing the execution of an 1 amendment to the Interlocal Agreement with the University of Washington 2 Tacoma, to continue temporary parking during construction of the hotel adjacent to the Greater Tacoma Convention Center, through December 31, 3 2020. 4 WHEREAS the City has conveyed property adjacent to the Greater Tacoma 5 Convention Center ("GTCC") to Yareton Investment & Management, LLC 6 7 ("Developer") for construction of a hotel/mixed-use project ("Project") that will 8 enhance operation of the GTCC, and 9 WHEREAS, it is anticipated that during construction on-street and off-street 10 parking located in the vicinity of the Project will be utilized by employees of the 11 Developer's general contractor, subcontractors, and other related parties who will 12 13 be working on the Project, and 14 WHEREAS, the University of Washington Tacoma ("UWT") currently owns 15 the property located between South 19th Street and South 17th Street, and 16 Court E and Tacoma Avenue South, which UWT has made available to the 17 Developer, in whole or in part, for the temporary use by employees of the 18 19 Developer's contractors and subcontractors for parking, and 20 WHEREAS, UWT and the City entered into an Interlocal Agreement ("ILA") 21 on May 3, 2018, to allow this temporary use to discharge stormwater to the City's 22 stormwater system, and 23 WHEREAS, UWT has identified parking scarcity to be an issue for UWT 24 25 students and local residents, and the ILA allows for construction parking to occur 26 on a private site so that demand for on-street parking does not exceed supply, and



	WHEREAS the Project was anticipated to be completed in early 2020,
1	however unanticipated conditions have caused the schedule to be extended, and
2	construction is now expected to be completed before December 31, 2020; Now,
3 4	Therefore,
4 5	BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TACOMA:
6	Section 1. That the proper officers of the City are hereby authorized to
7	execute an amendment to the Interlocal Agreement with the University of
8	Washington Tacoma, to continue temporary parking during construction of the
9 10	hotel adjacent to the Greater Tacoma Convention Center, through December 31,
10	2020.
12	Section 2. That the City Manager, or designee, is hereby authorized to take
13	and execute any additional measures or documents that may be necessary to
14	complete this transaction which are consistent with the approved form of
15 16	documents referenced by this Resolution, and the intent of this Resolution.
