SUMMARY AND PURPOSE:

A resolution revising the appointments of Council Members to various committees, boards, and commissions.

COUNCIL SPONSORS:

Mayor Victoria Woodards

BACKGROUND:

In addition to feedback from each Councilmember, Mayor Woodards strives to balance City Council committee, board, and commission assignments based on a number of criteria, including number of roles assigned.

The City of Tacoma dedicates 100% of its lodging tax to debt service on the Convention Center, resulting in the City's "Hotel Motel (Lodging) Tax Advisory Committee" being inactive and without a need for City Council representation. Councilmember Walker currently is appointed to this role.

Pursuant to the Tacoma City Charter and the rules, regulations, and procedures of the City Council, Mayor Woodards brings forward for your consideration a resolution that would strike the "Hotel Motel (Lodging) Tax Advisory Committee" from the list of City Council committee, board, and commission assignments, removing Councilmember Walker from that seat. The resolution would also add Councilmember Walker to the Parks Policy Group (filling the seat currently held by Councilmember Beale) and the Zoo Trek Authority (filling the seat currently held by Councilmember Hunter).

COMMUNITY ENGAGEMENT/ CUSTOMER RESEARCH:

None was completed in advance of this action. The appointments to the Parks Policy Group and Zoo Trek Authority could be revisited at any time as needed based on feedback that may emerge.

2025 STRATEGIC PRIORITIES:
