ITEMS OF INTEREST

1. Council Member Chris Beale provides the **attached amendment to Ordinance No. 28687 relating to the Six-Year Comprehensive Transportation Program.**
2. Planning and Development Services Director Peter Huffman provides **the attached memorandum regarding the status of the PDS Building/Development Code and Community Engagement Project** status.
3. **LASA continues to administer the City's coronavirus rental assistance program. A total of 324 payments have been made totaling \$278,625.44.**

Under the current program guidelines, applicants may receive a one-time payment of up to \$1,000, based on this criteria:

- Awards of up to \$1,000 are made based on need, directly related to current rental expense obligations, as verified by the landlord.
- City of Tacoma resident(s)
- Experienced loss of employment or reduction in wages due to COVID-19
- Income at or below 50% Area Median Income for Pierce County

The provider **is partnering with Pierce County's emergency rental assistance program to ensure all applicants maximize their access to rental assistance resources** (meaning applicants may also qualify to receive PMYersierce County rental assistance funding).

There were no additional gifts to the City's Rental Assistance Fund at the Greater Tacoma Community Foundation this week. In total, the fund has received 19 gifts totaling \$25,520

4. The **Infrastructure, Planning and Sustainability Committee provides the attached Council Action Memorandum** changing the date and time of their meetings.
5. In response to questions raised at the August 4th Study Session presentation regarding the Tacoma Dome Link Extension (TDLE) project, **Sound Transit provides the attached letter with additional information.** The letter details Sound Transit's past and ongoing outreach to the Freighthouse Square owner and tenants, and provides example images of light rail "tail tracks" similar in concept to what is proposed at the Tacoma Dome Station.

6. TV Tacoma is **one of three finalists for the NATOA (National Association of Telecommunications Offers and Advisors) Award for Overall Excellence** (Operating Budget \$500,000 to \$1,000,000) which recognizing outstanding programming by a Government Access station.

The NATOA Awards are annual awards that recognize excellence in broadcast, cable, multimedia and electronic programming produced by local government agencies.

TV Tacoma has been a top three finalist in the Overall Excellence category six times in the last ten years and brought home the award last year (2019) and in 2015.

TV Tacoma is also one of **three finalist for the program “artTown” in the category of Arts and Entertainment (Operating Budget over \$400,000)** “artTown” has also been frequently recognized by NATOA in this category, having won the award in 2015, receiving 2nd place in both 2017 and 2018 and 3rd place in 2019.

1 AN ORDINANCE relating to the Six-Year Comprehensive Transportation
2 Program; adopting the Six-Year Comprehensive Transportation
Improvement Program amended for the years 2020 and 2021-2026.

3 WHEREAS RCW 35.77.010 provides that the legislative body of each city
4 and town shall: (1) prepare and adopt a comprehensive transportation program for
5 the ensuing six calendar years and annually thereafter, pursuant to one or more
6 public hearings; (2) prepare and adopt a revised and extended comprehensive
7 transportation program; and (3) file with the Secretary of Transportation of the State
8 of Washington each one-year extension and revision thereof, and

11 its comprehensive transportation program the intended expenditure of revenues
12 for non-motorized transportation purposes, and

SUBJECT: Building/Development Code and Community Engagement Enhancement Update
DATE: August 26, 2020

Please see the information below regarding the status of the Planning and Development Services (PDS) Building/Development Code and Community Engagement Project status.

This project was established by Resolution No. 40443 due to the City experiencing rapid growth and development. Neighborhoods expressed related concerns regarding health and safety and requested more engagement from the City before and during construction projects.

PDS is strategically advancing this project by using a three-phased approach. The first phase was quick enhancements, including a new project sign for some development, and expanded SEPA notices and meetings.

The second phase is proposed to be legislative changes that provide PDS with additional administrative authority to address notification to residents, meeting requirements, enforcement mechanisms, air quality standards, and other recommended items. We believe with this additional authority we could more immediately develop relevant construction standards and policy using an equity lens that recognizes all construction impacts are not universal and residential neighborhoods may need enhanced construction criteria.

The third phase and final phase is intended to result in specific budgetary proposals directly related to the PDS commitment to help with positive community engagement while providing additional enforcement capacity.

PDS is anticipating presenting the phase two proposed legislative changes at the Infrastructure Planning and Sustainability meeting on October 14, 2020.

Freighthouse Square business outreach:

The Sound Transit team continues to have ongoing conversations with Freighthouse Square (FHS) business owners, tenants, and the building owner. We consider the meetings with the owner and the tenants as important yet distinct outreach efforts. Sound Transit met with the owner of Freighthouse Square, Brian Borgelt on 11/6 and 12/18. The 11/6 meeting was focused on introducing the Close to Sounder alternative and its potential impacts, while the 12/18 meeting was focused on listening to Brian's concerns with past Sound Transit construction projects.

The outreach team conducted field visits to FHS business on 11/8/19 and again on 11/22/19. The 11/8 meeting was focused on introducing the TDLE project, providing an overview of the timeline/process, and encouraging folks to participate in our November 2019 outreach period by attending Sound Transit hosted drop-ins. The 11/22 field visits were specific to discussing the Close to Sounder alternative. The outreach team is planning on contacting them over the next month (primarily via phone) to connect and update them on project planning. We will resume in person visits as soon as agency safety protocols allow. As a reminder no acquisition decisions are made until after the Sound Transit Board selects the project to be built which will be after the Final EIS is issued. Tail Track visuals:

As discussed at study session, it is confirmed that the tail tracks at Tacoma Dome Station will not cross East D Street at either of the 25th street or the Close to Sounder alternatives. The 26th Street station alternative station is located over the intersection of East 26th Street and East D Street, and the tail tracks extend further to the west. As a reminder, tail tracks are about 500 feet of elevated track that will extend west of the Tacoma Dome light rail station to provide sufficient space for storing two 4-car trains. They are necessary for our ongoing light rail operations for storage of out-of-service trains without interfering with revenue operations, or to stage trains at the beginning of service. Sound Transit requires tail tracks at all stations which will serve an end-of-line function even if on an interim basis. The tail tracks pictured below are at Angle Lake Station in Seatac. Of note, the tail tracks at Tacoma Dome could have a different column and guideway design features and the condition under the tracks could be different, but this should give a better sense of what they look like.
