HOMELESS STRATEGY



- Making homelessness Rare, Brief and One Time:
 - Addressing racial disparities and other root causes
 - Support funded providers to develop and employ systems to address racial inequities program delivery
 - Programs operated by and/or serve BIPOC communities
 - Use existing data from HMIS and SPARC report to develop targeted interventions
 - Strengthening outreach and engagement
 - Promptly identify and engage people living in places not meant for habitation, and those fleeing from violence
 - Support tailored intervention for subpopulations in homelessness system intersected with BIPOC
 - Strengthen access and availability of shelter
 - Strengthen the referral process to shelter, transitional housing, and supportive housing interventions
 - Strengthen safe exits from shelter to housing
 - Support efforts to expand and develop shelters
 - Housing
 - Identify and support permanent supportive housing programs
 - Strengthen eviction prevention strategies (AHAS 3.2 & 4.1)
 - Other supportive services
 - Diversify portfolio of supportive services (innovation)

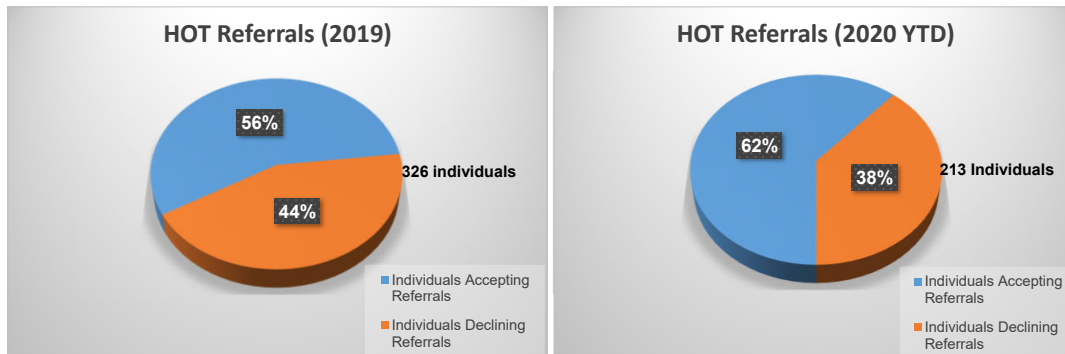

TEMPORARY SHELTER REGULATIONS

TACOMA MUNICIPAL CODE 13.06.630



- **Organizations currently operating under the regulation:**
 - Alzheimer Memorial Church
 - Bethlehem Baptist
- **Flexibility of shelter operations** (indoor, outdoor, safe parking, day, night, population specific)
- **Prospective shelter operators must go through permitting process**
